Mayor D. Backer and Members of Council:

The Town of Mattawa submitted two (2) Expression of Interest (EOI) requests for funding. One for the Ontario Community Infrastructure Fund (OCIF) for the Mattawan Street Wastewater and Water Mains Replacement on September 11, 2015 estimated at \$1,649,032.00 which provides 90% funding.

The second EOI for the New Building Canada Fund - Small Communities Fund (SCF) for the Ottawa and Champlain Streets Water Main Replacement was submitted on September 29, 2015 and is estimated at \$643,620.20 and provides up to 66% funding. Both of these projects have been identified as priority in our Asset Management Plan.

The Expression of Interest request is the first step in the application process. When successful at this phase, an invitation to submit a full application is granted. On January 4, 2016 (Correspondence 4.4), we received the good news that we have been successful in reaching the next step which is to submit the application for the Ottawa and Champlain Streets Water Main Replacement SCF request. The deadline for submission is February 12, 2016.

Being that we have been successful with this phase, Council directs staff to complete and file the application for funding. It is understood that this does not guarantee the approval for the funding request.

Recommendation:

That the Council of the Town of Mattawa authorize staff to submit an application under the New Building Canada Fund - Small Communities Fund for the Ottawa and Champlain Streets Water Main Replacement project.

The Mattawa Voyageur Days Committee is requesting that food vendors be permitted at Explorer's Point during Voyageur Days July 22-24, 2016. If Council approves locating food vendors at Explorer's point, vendors will be responsible to follow all regulations involved in By-Law 09-14.

Recommendation:

It is therefore recommended that refreshment vehicles regulated under By-law 09-14 be permitted to locate at Explorer's Point July 22-24, 2016 during Voyageur Days festival as requested by the Mattawa Voyageur Days Committee. Refreshment vehicle operators will be responsible for the following:

- Obtain all approvals before operating from the North Bay and District Health Unit, Fire Dept. and Building Dept. under sections 6 and 7 of By-Law 09-14.
- 2) Notify the By-law Department with all approvals no later than July 18, 2016 at 5:00 p.m. prior to installation at Explorer's Point.
- 3) Be responsible to ensure that the immediate area is cleaned at all times.
- 4) Exit Explorer's Point no later than Monday, July 25th, 2016 at 5:00 p.m.

Victor Jeske applied to the municipality in November (Correspondence 4.18 November 23rd Agenda) to erect a five foot fence around the entire perimeter of his dwelling which includes the front yard. Fence By-Law # 93-35, Section 7 (b) (i) does not permit a fence to be constructed higher than 3 feet in the front yard for a residential property.

The reason for the request for this fence increase is for privacy and a swimming pool.

The fence By-Law permits Council to make exceptions to the height requirements. In the past Council has granted similar requests. For these reasons the following is recommended:
