Mayor D. Backer and Members of Council:

The recent advertising of sale of land by public tender process for the property located at 265 Sixth Street, PIN 49101-0157 (LT) did not receive any submissions. The municipality now has two options under the Municipal Act which is to either re-advertise the sale of the property by public tender process within two years from the first date of the public sale or request the solicitor to prepare a Notice of Vesting to be registered on title for the land in question. The municipality would then inherit title to the lands in fee simple and would then be free to do and dispose of the property as it sees fit. The later sale of the property could be at any price decided by the municipality.

At the February 8th, 2016 regular meeting of Council, a resolution was carried to have Notices of Vesting completed for two other properties that did not sell under the same public tender process therefore for that reason, it is recommended that the same process occur with this property.

This process, once completed, will permit the tax arrears to be written off and the property may then be declared as a surplus asset and advertised for sale at Council's discretion under the municipal surplus lands policy.

In the correspondence section of the April 25, 2016 agenda, a letter (4.5) from the Municipality of Dutton Dunwich requested all Ontario municipalities support their resolution to request changes be effected to the IESO (Independent Electricity System Operator) process.

WHEREAS Invenergy was awarded a contract for the Strong Breeze Wind Project despite the fact that the Council of the Municipality of Dutton Dunwich surveyed the community as to whether its citizens were in favour or opposed to having an IWT project, and 84% of respondents stated they were not in favour;

AND WHEREAS Invenergy was awarded a contract for the Strong Breeze Wind Project despite the lack of municipal support;

AND WHEREAS Invenergy was awarded a contract for the Strong Breeze Wind Project with support from six Ontario First Nations communities, none of which are local First Nations Bands, and some of which are 1,000 km away from Dutton Dunwich.

AND WHEREAS the Municipality of Dutton Dunwich requests that:

- 1) The Municipal Support Resolution becomes a mandatory requirement in the IESO process.
- 2) That any points for Aboriginal participation in a given power project be limited to the First Nation who has a comprehensive claim on the land where the project will be built.
- 3) That any announcement to the successful bidders includes an explanation of the points awarded to each bid.

Recommendation:

That Council of the Town of Mattawa supports the Municipality of Dutton Dunwich's position of requesting changes be effected to the IESO process and that this resolution be forwarded to the Chair of the Board and President of IESO, the Minister of Energy, Elgin-Middlesex-London MPP Jeff Yurek and the Association of Municipalities of Ontario.
