### Mayor D. Backer and Members of Council:

The By-law Department is in the process of updating various municipal By-laws. The province requires the new By-laws be submitted to the Ministry of the Attorney General Crown Law office – Criminal in order for the enforcement of the By-law to occur.

The updated By-laws have been submitted, reviewed and generally accepted. The one exception was the Parking By-law. The Crown Law office suggested an administrative amendment be approved by Council which would allow for the enforcement of the By-law for disabled parking spaces. They suggested a title and a new clause be added to Part V which will allow for charges to be laid to vehicles not displaying a valid disabled permit. They also suggested a new item be added to Schedule "H" which would allow for the fine to be levied for parking in a disabled space.

### Recommendation:

That By-law 08-26 be approved which will amend Parking By-law 07-17 by including a title and a new clause to Part V, and Schedule "H" is amended by adding a new item #14 which adds a set fine to a person illegally parking in a disabled parking space.

BY-LAW NO. 08-26**

**TO AMEND BY-LAW NO. 07-17  
BEING THE CONSOLIDATED PARKING BY-LAW  
FOR THE TOWN OF MATTAWA**

**WHEREAS** Page 172 of Resolution Number 08-44 passed by Council on November 24, 2008 authorized the amendment to By-law 07-17 to provide for enforcement of the disabled parking spaces by allowing charges to be laid for persons not displaying a valid disabled permit.

**NOW THEREFORE** the Council of the Corporation of the Town of Mattawa hereby enacts the following:

1. Part V, Section 2 Title of By-law 07-17 is replaced with the following title:

**"SECTION 2 – REQUIREMENTS"**

2. A new section in Part V, entitled Section 3 – Regulations is to be added after Section 2 of Part V, which will state:

**"a) No person or organization shall:**


- (i) Park a vehicle in a designated parking space without a valid permit, or**
- (ii) Be entitled to the benefit of an exemption under this By-Law."**


3. Schedule "H" to By-law 07-17 be amended by adding Item #14, which will state:

14.	Park in a disabled space	Part V, section 3 a) (i)	\$300.00

4. This by-law shall come into force and effect upon being passed.
