THE CORPORATION OF THE TOWN OF MATTAWA

BY-LAW # 20-18

BEING a By-Law to amend By-Law No 11-17, which provides for the regulation of Recreational Open Air Burning within the Town of Mattawa.

WHEREAS under the authority granted in Section 7.1 of the Fire Protection and Prevention Act, S.O., 1997, as amended, Chapter 4, Municipal Councils may establish open air burning by-laws to regulate the setting of fires, including establishing the times during which open air fires may be set.

NOW THEREFORE the Council of the Corporation of the Town of Mattawa enacts as follows:

That By-Law No. 11-17 be amended as follows:

1. That Section 3 be amended by adding the following 3 (f) attached hereto:
 - 3 (f) Sid Turcotte Park shall be exempt from the setting of any fires out of doors in the Town of Mattawa between the hours of 6:00 a.m. and 6:00 p.m. on weekends, weekends being from Friday at 6:00 p.m. to Monday at 6:00 a.m..
2. This By-Law shall come into force and effect upon being passed.

READ A THIRD time and FINALLY PASSED this 4th day of August, 2020.
