RESOLUTION NO. 205-316

DATE: May 27, 2025

MOVED BY: Councillor Engelsdorfer

SECONDED BY: Councillor MacNaughton

WHEREAS on May 1st, 2025, the Province of Ontario designated Prince Edward County as a "Strong Mayor" community along with 168 other Ontario communities, granting enhanced powers to the Mayor; and

WHEREAS Strong Mayor powers significantly alter the balance of governance at the municipal level, undermining the role of Council in decision-making and weakening the fundamental democratic principle of majority rule; and

WHEREAS "Strong Mayor" legislation violates the principles and meaning of democracy, and local governance has, for generations, been built upon a foundation of shared, democratic decision-making; and

WHEREAS elected representatives and citizens from many municipalities throughout Ontario including several close neighbours such as Quinte West have expressed significant concern regarding the imposition and appropriateness of these powers; many councils have called for their repeal; and many mayors throughout the province have publicly recommitted to democracy by refusing to adopt "Strong Mayor" powers; and

WHEREAS Prince Edward County did not formally request or express a desire to be designated under the Strong Mayor framework; and

WHEREAS the government justified the expansion as a tool to build more housing, AMTCO has indicated there is no evidence that the legislation has impacted housing starts in municipalities that have previously been granted strong mayor powers; and

WHEREAS strong mayor powers create significant risks for municipal integrity increased division in local discourse, the blurring of roles threatening the neutrality of the unelected public service, and greater risk of improper influence (or the appearance thereof) particularly regarding local planning and development matters;

THEREFORE BE IT RESOLVED that the Council of the County of Prince Edward formally request that the Premier of Ontario and the Minister of Municipal Affairs and Housing recommit to the meaning and spirit of democracy and rescind the Strong Mayor legislation;

AND BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Premier of Ontario, the Minister of Municipal Affairs and Housing, Bay of Quinte MPP Tyler Allsopp, AMO, ROMA, and all other Ontario Municipalities.

Windsor City Council, at its meeting held April 28, 2025 adopted the following resolution:

Decision Number: CR182/2025

WHEREAS the Province of Ontario, through O. Reg. 530/22 under the *Municipal Act*, 2001, designated the City of Windsor as a "Strong Mayor" community, granting enhanced powers to the Mayor effective July 1, 2023; and,

WHEREAS the Strong Mayor powers significantly alter the balance of governance at the municipal level, undermining the role of Council in decision-making and weakening the fundamental democratic principle of majority rule; and,

WHEREAS the City of Windsor has a long history of collaborative, transparent, and accountable local governance built upon a foundation of Council-debate and shared decision-making; and,

WHEREAS several members of Windsor City Council, as well as municipally elected officials across the province and members of the public have expressed significant concern regarding the imposition of these powers; and,

WHEREAS the City of Windsor did not formally request or express a desire to be designated under the Strong Mayor framework; and,

WHEREAS a growing number of municipalities and elected officials across Ontario are questioning the appropriateness of the Strong Mayor system and are calling for its reconsideration or repeal; and therefore,

BE IT RESOLVED that Windsor City Council **FORMALLY REQUEST** that the Premier of Ontario and the Minister of Municipal Affairs and Housing immediately **REMOVE** the City of Windsor from the list of municipalities designated under the Strong Mayor legislation; and,

BE IT FURTHER RESOLVED that a copy of this resolution **BE SENT** to the Premier of Ontario, the Minister of Municipal Affairs and Housing, all regional Members of Provincial Parliament, all Ontario municipalities, and the Association of Municipalities of Ontario (AMO) for their awareness and support.

Policy Update - Province Introduces Bill 30

Province Introduces Bill 30, Working For Workers Seven Act, 2025

Yesterday, the Ontario government tabled its seventh <u>Working for Workers</u> <u>Act</u> (Bill 30). While the stated objective of supporting workers amidst potential job losses arising from the US-Canada trade dynamic is noted, one of its proposals raises significant concerns -- exempting Skills Development Fund

Capital Stream-supported capital projects from the requirements of *The Municipal Act* and *The Planning Act*.

Earlier exemptions from municipal planning approvals, such as those related to public universities and "community service facilities" like K-12 schools, hospitals, and long-term care homes are aimed to expedite planning for public entities. Bill 30, however, marks a significant shift by:

- Extending expedited planning processes and exemptions from municipal authorities to private entities without the robust accountability and regulatory frameworks that characterize broader public sector bodies, solely by virtue of their qualification to access a source of provincial funding with broad eligibility; and
- Going beyond exemptions to *The Planning Act* to include exemptions to *The Municipal Act*. These powers could allow for waivers from municipal bylaws, including those related to property tax, development charges, and other local requirements with no clear purpose or rationale.

The cumulative impact of what is now the proposed ability of four separate Ministers to override municipal land use planning and other authorities also raises significant concern by increasing the likelihood of unintended consequences and diffuse accountability. Currently before the legislature are proposals to provide powers to:

- The Minister of Infrastructure to use Minister's Zoning Orders (MZOs) to override The Planning Act as part of Bill 17;
- The Minister of Economic Development, Job Creation and Trade to create Special Economic Zones (SEZs) to override *The Planning* Act and The Municipal Act as part of Bill 5; and
- The Minister of Labour, Immigration, Skills and Training to override *The Planning Act* and *The Municipal Act* for those in receipt of capital funding from the Skills Development Fund under Bill 30.

AMO continues to support the need for bold and innovative action to respond to unprecedented economic challenges. However, the threat of tariffs cannot be used to justify any and all proposals to override provincial and municipal laws. AMO will continue to analyze the proposal and seek opportunities to provide commentary to the legislature.

BACKGROUND

The Physician Recruitment Committee consists of appointed Members from Councils of the Town of Mattawa (Raymond Bélanger), Townships of Bonfield (Narry Paquette) and Papineau-Cameron (Mélanie Chenier) and the Municipalities of Calvin (Richard Gould) and Mattawan (Janet McNabb).

Other members of the committee consist of Dr. Bryan Williams (Chief of Staff), Tanya Bélanger (President & CEO), Amy Morrison (VP Corporate Services & CFO/Administrator), Christine Thompson (VP Clinical Services/CNO), Kayla Michaud (Physician Recruiter) and Lyse Coté (Recorder).

ANALYSIS & DISCUSSION

Return of Service Agreements:

We have three agreements with the upcoming physicians.

- Dr. Taylor Wilkins: Originally, she was scheduled to start in July or August 2025 but has
 postponed to January 2026 for personal reasons and to take locum positions to gain
 more experience. She is within her agreement and has expressed interest in doing
 locums at our facility.
- **DJ Houle:** Is scheduled for July 2026. He is excited about joining and hopes to bring his wife into the practice. His contract specifies a two-month timeline.
- Adam Ritchie: Is scheduled for July 2027.

Locum Coverage:

Smaller hospitals often provide incentives to attract locums.

- Incentives were necessary during the Christmas holiday to cover shifts when another
 physician had to drop their scheduled shifts. Dr. Williams has been helpful in assisting
 with locum coverage.
- We had another locum who recently found a hospital closer to his home and had to give up several shifts. We had to cover just under 20 shifts. The Emergency Department Locum Program (EDLP) program has been helpful in covering the shifts to date.

Physician Transition and Feedback:

- We are working closely with locum physicians to determine what improvements can be made in-house during transitions.
- We will explore what the new physicians would like to see in their roles.

OHA and Vic Fedeli Meeting:

- The OHA was refraining from engaging with hospitals during the election campaign, which is why Crystal Burns gave her regrets to that meeting.
- Vic Fedeli, MPP for Nipissing, has scheduled a meeting in the community. This could be an opportunity to discuss the community's limited resources.

Physician Staffing Goals:

 Given our reliance on locums, we need more than three physicians to meet staffing needs. The current physicians recommend eight physicians to replace the four previous ones; however, the CEO suggested we aim for six physicians, with a potential new recruit in 2028.

Nurse Practitioner (NP) Consideration:

 Could an NP alleviate the workload? If funding allows, an NP could be a good support, but this is dependent on provincial government support. Under current legislation, an NP would be a good support but would not eliminate the need to have a physician in the Emergency Department.

Health Home Model:

• The CEO expressed interest in starting a pilot for a health home model, subject on sufficient funding, as it aligns with our vision for healthcare.

FINANCIAL IMPLICATIONS

The Council of the Corporation of the Town of Mattawa approved a five-year annual financial commitment of \$13,769.54 per year for the Mattawa Physician Recruitment Initiative. This annual contribution will begin in 2024 until the final payment in 2028 payable in January of each year.

The CFO provided an overview of the budget planning on 2022-2028. Recruitment budget planning and funds are attached for reference.

- The budget comparison report covers the fiscal year-to-date ending December 31, 2024.
- We are currently under budget.
- Physician 4 position remains to be filled.
- On the expense side, we are under budget, mainly due to lower costs for advertising and fairs. Only one fair in Sudbury was attended.
- Overall, we are on target for this fiscal year.
