Dear Hon. Greg Rickford:

This is Resolution No. 2025-279 which was passed by Council at its Regular Meeting held Tuesday, August 12, 2025.

Resolution No. 2025-279:

"Whereas the Northern Ontario Resource Development Support (NORDS) pilot program was introduced to help Northern Ontario municipalities address infrastructure pressures resulting from natural resource sector activities;

And Whereas the program has been well received and has allowed municipalities, such as the City of North Bay, to strategically accumulate multi-year allocations in order to support large-scale infrastructure initiatives critical to community development and economic growth;

And Whereas the City of North Bay recognizes the importance of modern, safe, and efficient infrastructure to support economic growth and industrial competitiveness;

AND WHEREAS the Seymour Street Widening project from Station Road to Wallace Road, including a signalized intersection, is a critical continuation of the intersection improvement at Hwy 11/17 and Seymour Street, directly supporting a high-value industrial zone;

And Whereas this arterial corridor enables key sectors such as mining, forestry, construction, and manufacturing to receive and ship goods efficiently, impacting markets provincially and beyond;

And Whereas the updated total Seymour Street Widening project budget of approx. \$11 million includes contributions from multiple funding programs such as NORDS (\$2 million) and OCIF (\$4,259,448).

Therefore Be It Resolved That the Council of the City of North Bay strongly urges the Government of Ontario to make the Northern Ontario Resource Development Support (NORDS) program a permanent fixture of its support to Northern municipalities;

And Further Be It Resolved That the Province consider expanding program eligibility to recognize the significant impact that agricultural equipment and operations have on municipal infrastructure, particularly in rural communities;

And Further Be It Resolved That the Council of the City of North Bay formally supports the principle of stacking (accumulating) funding from multiple grant and infrastructure programs to advance strategic capital works, such as the Seymour Street Widening project, and requests continued flexibility from higher levels of government to enable effective financial planning and timely delivery of large-scale municipal infrastructure initiatives;

And Further Be It Resolved That a copy of this resolution be forwarded to the Minister of Northern Development, the Minister of Agriculture, Food and Agribusiness, the Minister of Infrastructure, the Minister of Natural Resources, Nipissing MPP Victor Fedeli, the Association of Municipalities of Ontario (AMO), the Federation of Northern Ontario Municipalities (FONOM), the Northwestern Ontario Municipal Association (NOMA), Rural Ontario Municipal Association (ROMA) and all Northern Ontario municipalities for their awareness and support."

WHEREAS democracy is healthy when everyone is able to participate fully and safely and contribute to the well-being of their community;

AND WHEREAS we are witnessing the dissolution of democratic discourse and respectful debate across all levels of government and in neighbouring jurisdictions;

AND WHEREAS Ontario's municipally elected officials are dealing with increasingly hostile, unsafe work environments facing threats and harassment;

AND WHEREAS social media platforms have exacerbated disrespectful dialogue, negative commentary, and toxic engagement which disincentivizes individuals, especially women and candidates from diverse backgrounds from running for office;

AND WHEREAS better decisions are made when democracy is respectful and constructive and the voices of diverse genders, identities, ethnicities, races, sexual orientation, ages and abilities are heard and represented around municipal council tables;

AND WHEREAS the Association of Municipalities of Ontario's Healthy Democracy Project has identified concerning trends with fewer people voting in local elections and running for municipal office;

AND WHEREAS in 2024, female elected representatives from across Halton formed a group called H.E.R. (Halton Elected Representatives) which pledged to speak out against harassment and negativity in politics and called on elected officials to uphold the highest standards of conduct;

AND WHEREAS H.E.R. Halton has launched a campaign called Elect Respect to promote the importance of healthy democracy and safe, inclusive, respectful work environments for all elected officials that encourages individuals to participate in the political process;

AND WHEREAS on June 5, 2025, the Canadian Association of Feminist Parliamentarians launched a non-partisan "Parliamentary Civility Pledge" to encourage all parliamentarians to commit to end workplace harassment and increase civility on Parliament Hill, modelled after the pledge developed in Halton by representatives of H.E.R.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Smiths Falls supports the Elect Respect pledge and commits to:

- •Treat others with respect in all spaces—public, private, and online,
- •Reject and call out harassment, abuse, and personal attacks,
- •Focus debate on ideas and policies, not personal attacks,
- •Help build a supportive culture where people of all backgrounds feel safe to run for and hold office.
- •Call on relevant authorities to ensure the protection of elected officials who face abuse or threats, and
- •Model integrity and respect by holding one another to the highest standards of conduct.

AND THAT the Council of the Corporation of the Town of Smiths calls on elected officials, organizations and community members to support the Elect Respect campaign and sign the online pledge at www.electrespect.ca;

This letter is to inform you that the Council of the Township of Woolwich passed the following resolution at their meeting held on September 23, 2025:

WHEREAS in December 2023, the Minister of Indigenous Services introduced house government bill C-61: An Act respecting water, source water, drinking water, wastewater and related infrastructure on First Nation lands also known as the First Nations Clean Water Act; and

WHEREAS in an open letter to Members of Parliament on December 12, 2024, the Assembly of First Nations (AFN) called on all Members of Parliament to prioritize the advancement of Bill C-61, calling it "a step toward addressing the long-standing water issues faced by First Nations"; and

WHEREAS Bill C-61 was not passed into law before Parliament was prorogued on January 6, 2025; and

WHEREAS Minister of the Environment, Conservation and Parks Todd McCarthy has been unclear on Ontario's position on this legislation, identifying Bill C-61 as a potential piece of legislation that would "undermine competitiveness" and "delay project development" before apologizing for any confusion and clarifying the need to "bring clean drinking water to First Nations communities, while also bringing the kind of regulatory certainty that attracts investment in businesses and communities"; and

WHEREAS Prime Minister Mark Carney and Indigenous Services Minister Mandy Gull-Masty have indicated the Canadian government's support for introducing legislation like Bill C-61 in the fall of 2025; and

WHEREAS as of September 2025, Indigenous Services Canada data shows that while 93 long-term drinking water advisories have been lifted, since November

2015, 37 long-term drinking water advisories remain active, including in 27 communities in Ontario; and

NOW THEREFORE be it resolved that the Council of the Township of Woolwich:

- Calls on the Government of Canada and the Minister of Indigenous Services to reintroduce legislation to ensure First Nations have the right to clean and safe drinking water in the Fall of 2025 in the same form as Bill C-61;
- 2. Calls on the Government of Ontario and the Minister of the Environment, Conservation and Parks to support this important Federal legislation; and
- 3. Directs staff to forward this resolution to the Prime Minister, Minister of Indigenous Services, Premier of Ontario, Minister of the Environment, Conservation and Parks, Assembly of First Nations and all Municipalities in Ontario.

WHEREAS fixed funding levels amid rising labour, materials and climate resilience costs have eroded the purchasing power of the \$400 million envelope, jeopardizing municipalities' ability to deliver and sustain essential services without incurring unsustainable debt;

WHEREAS predictable, multi-year funding indexed to real-world cost drivers is critical for municipalities to develop, finance and execute long-term asset management plans, reduce emergency repairs and leverage complementary federal and private infrastructure financing;

WHEREAS the Township of Edwardsburgh Cardinal requires a steadfast provincial partner to extend and enhance OCIF beyond 2026, ensuring infrastructure resilience, fiscal sustainability and equitable access for all small and rural municipalities;

- 1. The Township of Edwardsburgh Cardinal calls upon the Government of Ontario to extend the annual OCIF envelope at not less than \$400 million beyond its current five-year term ending in 2026, with no reductions in subsequent provincial budgets.
- 2. The Province be requested to index the total annual OCIF envelope—and each individual municipal allocation—to the Ontario Consumer Price Index (CPI), calculated on a calendar-year basis and disbursed in the first quarter of each fiscal year.
- 3. The Ministry of Infrastructure establish a new five-year OCIF funding framework that guarantees annual envelopes and allocation percentages by municipality, enabling long-term capital planning and stable cash-flow management.
- 4. The Province undertake a formal review of the OCIF allocation formula at least once every four years, incorporating current municipal asset management data, demographic projections, climate resilience metrics and rural equity considerations.
- 5. A dedicated contingency reserve equal to 5 percent of the annual OCIF envelope be created within the fund to address extraordinary cost escalations, emergency repairs or project overruns without reallocating core funding.

WHEREAS the Township of Edwardsburgh Cardinal acknowledges that municipal infrastructure—roads, bridges, water and wastewater systems—underpins public safety, economic vitality and quality of life in Ontario's rural and small urban communities;

WHEREAS the Ontario Community Infrastructure Fund (OCIF) was created in 2015 to assist small and rural municipalities facing infrastructure deficits that exceed their local revenue capacities;

WHEREAS in 2022 the Government of Ontario committed to increase the annual OCIF envelope from \$100 million to \$400 million over a five-year term, with that commitment scheduled to expire at the end of fiscal 2026;

WHEREAS fixed funding levels amid rising labour, materials and climate resilience costs have eroded the purchasing power of the \$400 million envelope, jeopardizing municipalities' ability to deliver and sustain essential services without incurring unsustainable debt;

WHEREAS predictable, multi-year funding indexed to real-world cost drivers is critical for municipalities to develop, finance and execute long-term asset management plans, reduce emergency repairs and leverage complementary federal and private infrastructure financing;

WHEREAS the Township of Edwardsburgh Cardinal requires a steadfast provincial partner to extend and enhance OCIF beyond 2026, ensuring infrastructure resilience, fiscal sustainability and equitable access for all small and rural municipalities;

NOW THEREFORE BE IT RESOLVED THAT

- 1. The Township of Edwardsburgh Cardinal calls upon the Government of Ontario to extend the annual OCIF envelope at not less than \$400 million beyond its current five-year term ending in 2026, with no reductions in subsequent provincial budgets.
- 2. The Province be requested to index the total annual OCIF envelope—and each individual municipal allocation—to the Ontario Consumer Price Index (CPI), calculated on a calendar-year basis and disbursed in the first quarter of each fiscal year.
- 3. The Ministry of Infrastructure establish a new five-year OCIF funding framework that guarantees annual envelopes and allocation percentages by municipality, enabling long-term capital planning and stable cash-flow management.
- 4. The Province undertake a formal review of the OCIF allocation formula at least once every four years, incorporating current municipal asset management data,

demographic projections, climate resilience metrics and rural equity considerations.

- 5. A dedicated contingency reserve equal to 5 percent of the annual OCIF envelope be created within the fund to address extraordinary cost escalations, emergency repairs or project overruns without reallocating core funding.
- 6. The Ministry of Infrastructure publish an annual OCIF performance report—including program disbursements, allocation adjustments and reserve expenditures—in a transparent, publicly accessible online dashboard.
- 7. The Clerk of the Township of Edwardsburgh Cardinal forward this resolution to:

It was great to see you at the Empire Club last week for Greg Ebel's speech. Thank you for your insightful and compelling closing remarks. Build Canada Now: Compete or retreat

Thanks, Derek for that kind introduction.

And thanks Kent and Saurabh for the invitation to speak to the Empire Club.

It's great to be back in Ontario - the province of my birth and where I grew up.

Deep roots as my father's family were Empire Loyalists.

Of course, Enbridge is in just about every home and business – so this is a special place on many fronts for me and our company.

The moment

Seventy years ago, Canada made a choice that helped to define a century.

We built the St. Lawrence Seaway – a continental gateway that connected our products and our economy to world markets.

It was a monumental feat of both engineering and foresight.

A shared effort that took vision and resolve.

When the locks opened and ships began to move, our economy moved with them.

Prairie grain flowed. Ontario manufacturing reached farther.

Canadian ambition met global demand.

And as with the railroad in the 19th century, we were reminded of an important national truth: when Canada builds, Canada prospers.

Today, our country – and our economy – faces another pivotal moment.

The world is restless and changing fast...and we can't stop or control that.

Our trading partners are re-wiring supply chains.

Energy security is now national and economic security.

Capital is nervous – flowing toward certainty and results.

Canadians – practical as ever – are asking straightforward questions...

Will we have the courage to take advantage of this moment?

Will we once again build and prosper?

Or, will we miss the opportunity - again?

The opportunity

Two years ago, many of you were with me when I addressed the Toronto Board of Trade.



At that time, I spoke of a missed opportunity on major energy projects – and how we were creating the conditions for the world to move on without us.

Today, I stand before you again, and I'll put it plainly: we can't walk anymore; we need to run – fast.

The last 10 years have been a competitiveness disaster for Canada.

The next 10 can be a renaissance – if we choose to lead.

This is our second chance. (One Doesn't get many of those.) And it is a better opportunity than before – but it comes with higher stakes and less time to take action.

I believe we can build, compete, and win.

But winning requires decisions – urgent, confident, investible decisions.

Decisions that will lead to Canada becoming the best place in the world to build the energy infrastructure and critical-resource projects that fuel jobs and growth across the economy.

The stakes

Let's be clear about the stakes.

Energy isn't a niche file. It is a core driver of Canadian prosperity.

The energy sector contributes more than 10% of Canada's GDP.

It's a centerpiece of trade - making up about one third of total Canadian goods exported.

From a Toronto perspective, these are numbers that sit alongside, and often anchor, the fortunes of our financial services, manufacturing, and technology ecosystems.

In other words, this is not a provincial story. This is not a regional story.

This is a Canadian story.

The Prime Minister has made it clear that he recognizes both the importance – and the potential – of the energy industry.

He has pledged to create the conditions for Canada to become, and I quote, a "superpower of both clean and conventional energy."

On election night he declared without hesitation that it was time to "build, baby, build."

That language matters. That enthusiasm matters.

And we welcome the government's follow-through – including Bill C-5, which – while not perfect – begins to modernize how infrastructure projects get built in this country.

That said, we have a long way to go.

Canada has extraordinary resources, a skilled workforce, and leading environmental standards. Yet we are not moving fast enough.

Projects linger. The permit process stretches on. Capital looks elsewhere.

At Enbridge, we know it first-hand. We have tried to build nation building pipelines and we have the scars to prove it.

Earlier this year, a public policy forum report put it plainly: Canada has the tools and talent to lead – but our processes too often slow or stall projects before they reach a final investment decision.

The report counts more than \$600 billion in proposed or active resource and infrastructure projects nationwide.

If we move on them decisively, the modelling shows up to \$1.1 trillion in additional GDP by 2035.

That's real, measurable prosperity and jobs – waiting to be unlocked.

And to be clear: this isn't about government doing the building. Far from it.

Markets build when governments establish clear rules, set credible timelines, and make consistent decisions.

That's the partnership we're calling for – because the energy sector is ready to invest, partner with indigenous nations, and deliver for the country.

Our ask is simple: match our urgency. **Speed** is a necessity, not a nice to have.

I often hear that we need to "approve projects as fast as other jurisdictions."

My friends, I am afraid we don't have that luxury anymore. That would be too little too late.



We're losing this race.

We now need to be a lot faster than our competition just to catch up, just to create confidence.

I recognize that's uncomfortable to hear, but it's the situation we have put ourselves thanks to a decade where political vanity ran roughshod over economic utility.

The priorities

This past spring, shortly after election day, I joined with 37 other CEOs from Canada's energy industry.

Together, we wrote an open letter to our newly elected prime minister.

And at the opening of parliament just a few weeks ago, we followed that up with another letter – this one signed by nearly 100 CEOs representing companies across the energy value chain.

The largest six of these companies alone make up over 10% of the TSX-it's a serious group of patriots.

We outlined five key government actions that would put Canada in a position to seize this moment – and take a big step toward fulfilling the prime minister's goal of creating an energy superpower.

The first? We need smarter, simpler regulation.

Consider the federal impact assessment act and the west coast tanker ban.

Together, they increase both costs and uncertainty and stifle investment.

Canadian project approvals are so complex and unpredictable that even the most responsible, Indigenous-supported, and environmentally sound proposals can be delayed for years – sometimes indefinitely.

Or worse, a government changes the rules of the game with a stroke of the pen after approvals are granted. No one can be a proponent in that jurisdictional quagmire.

Now, none of us is calling for weaker environmental oversight.

Instead, we are urging government to adopt smarter, clearer, and faster processes – so we can attract investment, take risks, and build for tomorrow.

Let's build a sustainable system that offers certainty and predictability without sacrificing standards.

We don't need added layers or jurisdictions. What we need is the courage to act.

If we get regulation right, we don't just kickstart projects – we restore Canada's reputation and spark new global confidence in this country as a destination for capital.

And let's be honest, we simply don't have enough capital at home here in Canada.

We need to attract investors from abroad to build all the projects we are interested in completing. We need them to be confident in our ability to deliver.

Second: we need shorter and more predictable timelines.

Getting a project approved today can take five years or longer.

Meanwhile, in the United States, timelines are shortening. In Europe, permitting reforms are already underway.

Canada cannot afford to be the slowest mover in a guickening world.

The Prime Minister has pledged to complete major federal project reviews in two years.

That's a good start – though with digital permitting, clear expectations, and concurrent reviews across agencies, we could do even better.

And, if we can do major projects in two years or less, why can't we do smaller projects in half or a third of that time? Surely, we are capable of that!

Meeting shorter timelines would give large and small project proponents confidence in their own commitments to investors.

Investors don't need a guarantee of approval. But they do need the guarantee of a timely decision.

The third government action: we need to reward progress, not punish it.

Right now, Canada's unlegislated emissions cap on oil and gas is creating unnecessary uncertainty.



It threatens to arbitrarily limit production, even in cases where Canadian oil and gas producers are reducing emissions per barrel and investing in cleaner operations, not to mention helping the world's poorest and least sustainable countries do better.

Look at the numbers: Canada's contribution to global emissions dropped from 1.75% in 2006 to 1.42% in 2022 - and the trend continues downward. Canada is a critical part of the solution not the problem.

We are well-positioned to use our energy to help countries like China and India transition away from coal – a net benefit for both nations, and for the world

Now, it's good news that Canada is finally moving major LNG projects to completion – and at last opening an export door to Asia.

That is overdue progress, a win for Canadian workers, and a step toward a more resilient energy system.

But it's a decade later than it should have been.

And the worst thing about that? The United States beat Canada to the puck - growing to eight operational export terminals over the past decade from none – with another eight under construction and 10 more approved.

Fourth: we need to attract investment with coherent and competitive policy.

The current federal carbon levy on large emitters is among the highest in the world. And from a competitiveness perspective, it's a silent killer of iobs and investment.

Canada is the only country among the top 10 oil producing nations that imposes a federal carbon price on its oil exporting business.

Why are we tying one arm and one leg behind our own companies' backs and giving a boost to every major competitor – the Saudis, the Brazilians, the Russians, and the United States?

Seriously, who does that to a key domestic industry and national champions?

It makes it harder to plan and harder still to attract long-term investments. Let's use what we know works.

Let's empower provinces to tailor this carbon regulation to their local economies because we know that the transition to net zero is not linear or uniform across sectors, markets and regions.

And let's design a system that protects export industries and incentivizes innovation.

The fifth and final action that we're calling for: we need to accelerate Indigenous partnership in energy projects – including equity participation.

True progress must be shared – and that includes meaningful Indigenous participation in the things we build together.

The federal Indigenous Loan Guarantee Program unlocks access to lowcost capital for Indigenous ownership in major projects.

In May, the first federal guarantee – some \$400 million – helped dozens of First Nations acquire a 12.5% interest in our Westcoast natural gas pipeline.

That's durable revenue, governance voice, and shared prosperity – reconciliation in action.

Let's broaden and accelerate this.

Because when Indigenous nations are owners, projects are better, timelines are shorter, and benefits can be shared by all.

Project equity is the next frontier for Indigenous participation.

There are different ways to realize this, but perhaps the major land claims that many Indigenous nations look to settle and which the federal government should – and I believe does – feel an obligation to complete, could be a source of equity should Indigenous nations believe that would be a worthy endeavour and reason to accelerate the conclusion of certain claims.

Obviously, any action on this front would need to recognize and respect Indigenous process and consultation.

The context

These five priorities – these five calls to action – become even more essential when you consider the reality of our country and the context of the current moment.



Energy is what keeps plants running in Windsor and Oshawa, data centers humming in the GTA, and homes warm in winter from thunder bay to Port Colborne.

When energy is secure, affordable, and sustainable, households have more to spend, manufacturers have cost certainty, and Canada's exports grow.

When it isn't, we feel it – in our bills, our pay cheques, and our government budgets and our communities at large.

And people get that. Perhaps more than ever before. Public opinion is shifting dramatically.

Opinion surveys show that 88% of Canadians now rate oil and gas as important to Canada's economy - a new high.

Support for a western oil pipeline has risen to nearly three-quarters of Canadians – up from 50% just a few years ago.

And 72% agree it's possible to build a new pipeline and reduce greenhouse gas emissions at the same time.

Overall, public support for expanding oil and gas exports to help global energy security has grown by 10 points in just six months.

The message is clear: Canadians are being pragmatic. They want responsible builds that share the benefits and deliver results.

They recognize that the Canada – U.S. energy corridor is still our lifeblood. Ninety-seven percent of Canadian crude exports went to the U.S. in 2023.

They also understand the risk of having only one customer for such an important element of our economic health.

Opening additional westward and eastward routes would make our economy more resilient, our allies more secure, our trade less vulnerable to the next tariff shock, and our sovereignty more robust.

There is a good reason the Alberta government has become the proponent of a pipeline to the north coast of BC.

The previous government's tanker ban effectively makes that export pipeline illegal. No company would build a pipeline to nowhere.

The tanker ban is a great example of how things will have to change to allow our country to maximize its economic potential.

Let markets and real demand guide routes and capacities, while government focuses on enabling the conditions for success.

That includes investing in skills development and the trade infrastructure that ties into ports and rail.

And, Ontario has a special role to play.

Its financial services engine prices risk, aggregates capital, and exports Canadian know-how with every project we finance.

Its manufacturers and technology firms supply the turbines, control systems, and software that make modern energy systems efficient and safe.

And Ontario's nuclear refurbishments underline a crucial point: big builds deliver big payoffs when done well – thousands of jobs, domestic supply chains, and decades of reliable, low-carbon power that anchor competitiveness.

In Canada, energy isn't just a western strength. It's an Ontario opportunity and competitive necessity.

And all of Canada would benefit from the people of this province standing up and speaking out loudly in favour of energy projects - fully recognizing that while the largest of these would be in the west, they all deliver greater prosperity and economic security across our country.

Conclusion

By way of conclusion, I'll say this: as Canadians we have a reputation for being polite, low-key, maybe even a little self-deprecating.

But this is no time for modesty or staring at our shoes.

This is the time to remind ourselves: we should be the best at this.

We should make the most of our resource bounty.

We should lead the way and show the world how it's done – wisely, responsibly, efficiently, effectively.

The need is there. The rationale is there. The public sentiment is there.

We've learned some hard lessons in 2025.

Foremost among them: we can't blindly rely on others.



We need to build for ourselves. Take care of ourselves. Invest in ourselves.

Seventy years ago, Canadian leaders chose to develop the St. Lawrence seaway. We connected our economy to the world and bet on our capacity to deliver.

Now is the time for Canadians and Canadian leaders to show more than a little self interest in our **own** future and the future of **our** country.

No, not by ignoring the world at large – that has never been our way – but by recognizing that if we are not healthy as an economy, as a country and as a united people, we will have far less – if anything – to offer the world in the longer term.

A world that will need our values, our innovation, our initiative, and yes, our natural resources.

So, perhaps the choice is quite easy after all...

Let's **Build Canada Now** so we can build a better world tomorrow.

Re: Extended Producer Responsibility for Blue Box Recycling Collection and Impacts to Small Businesses located in Mixed-Use Properties

Dear Minister McCarthy,

Please be advised that at its meeting held on October 6, 2025, the Council of the Town of Whitby adopted the following as Resolution # 191-25:

Whereas in 2016 the Waste-Free Ontario Act was enacted, which also enacted the Resource Recovery and Circular Economy Act (RRCEA) and the Waste Diversion Transition Act; and,

Whereas the RRCEA and its associated regulations focus on strengthening Extended Producer Responsibility for materials like used tires and blue box recycling; and,

Whereas on November 23, 2020, Town Staff submitted comments to the Environmental Registry of Ontario on the proposed blue box regulation, which highlighted concerns about the lack of a requirement for blue box recycling collection for certain "non-eligible" sources like small businesses located in mixed-use properties which are prevalent in Business Improvement Areas; and,

Whereas in the Town of Whitby there are approximately 200 small businesses in mixeduse properties who currently receive blue box collection and are impacted by the blue box regulation and will potentially lose blue box collection services; and,

Whereas in June 2021 the Province of Ontario released Blue Box Regulation O. Reg. 391/21, under the RRCEA which transitions the financial and operational responsibility of recycling from municipalities to the producers of packaging and paper products; and,

Whereas Circular Materials Ontario (CM) was named the Producer Responsibility Organization taking on all blue box recycling responsibilities in Ontario over a three-year transition period; and,

Whereas the Region of Durham has indicated that the estimated costs to continue to provide blue box recycling for small businesses after the 2026 transition date to CM was exorbitant and no longer a core responsibility of the Region pursuant to Provincial legislation; and,

Whereas on July 1, 2024, the Town of Whitby and all local area municipalities in Durham Region transitioned from the Regional blue box program to the CM blue box program; and,

Whereas the Region of Durham and CM negotiated a temporary agreement to continue providing blue box collection services to small businesses in mixed-use properties during the blue box transition period from June 30, 2024 to December 31, 2025, however, CM will not service these small businesses or any non-residential properties effective January 1, 2026, as they are not included as "eligible sources" under Blue Box Regulation 391/21; and,

Whereas on October 17, 2024, Mayor Roy sent a letter to the Honourable Andrea Khanjin, who was at that time the Minister of Environment, Conservation and Parks, advocating for changes to the blue box regulation as it related to blue box collection for small businesses; and,

Whereas on June 4, 2025, the Ministry of Environment, Conservation and Parks proposed amendments to the RRCEA through the Environmental Registry of Ontario and staff comments were submitted jointly to the Municipal Waste Association and Regional Public Works Commissioners of Ontario on June 13, 2025 highlighting concerns with the blue box regulation and impacts to small businesses located in mixed-use properties; and,

Whereas on August 15, 2025, CM hosted a municipal engagement session with members of a Municipal Working Group, reviewing a proposal for blue box recycling for non-eligible sources; and,

Whereas it is not clear how the recycling collector will differentiate commercial recycling from residential recycling at mixed-residential locations as they are typically set out together; and,

Whereas the proposal submitted by CM must be agreed to by all three Producer Organizations before it will be considered by the Ministry of Environment, Conservation and Parks; and,

Whereas on October 1, 2025, all three Producer Organizations, which includes CM, Ryse Solutions, and Landbell Canada, provided a letter to Mayor Roy outlining their decision to not proceed with blue box collections for small IC&I locations, citing, "system capacity limitations, current regulatory obligations, and time constraints that make it impractical for CCS to provide (blue box) collections from IC&I locations"; and,

Whereas on October 1, 2025, the Honourable Todd McCarthy, Minister of the Environment, Conservation, and Parks provided a letter to the Town of Whitby advising that the Producers will not voluntarily continue to offer blue box services to municipalities for small business locations.

Now therefore, be it resolved:

1. That the Council of the Town of Whitby requests that the Ministry of Environment, Conservation and Parks amend Blue Box Regulation 391/21 to require Producers to provide blue box collection services to businesses located in mixed-use properties;

and,

2. That the Mayor be requested to author a letter to the Minister of Environment, Conservation and Parks advocating for changes to Blue Box Regulation 391/21, and that a copy of this letter be forwarded to all Ontario Municipalities, Ontario Big City Mayors (OBCM), the Association of Municipalities of Ontario (AMO), and the Ontario Business Improvement Area Association (OBIAA).

BACKGROUND

On June 21, 2025, a downburst hit Samuel De Champlain Provincial Park leaving over 200 campers trapped and left homeless. This was in Calvin Township and their evacuation centre was the Ecology Centre which was situated in the middle of the devastation. The Town of Mattawa was approached by Calvin Township to open up our evacuation Center as an evacuation shelter for all the campers.

I received an email on June 26, 2025 from the CEMC for Papineau-Cameron wanting to list the Mike Roden Arena as an evacuation Centre in their Emergency Response plan and wanting to know how to start the process.

At the regular meeting on Monday September 8, 2025 Council received a formal request in correspondence and Council directed staff to begin the process of creating a plan with the Township of Papineau-Cameron.

ANALYSIS AND DISCUSSION

I had a discussion with our Emergency Management Ontario, Field Officer about this and she advised me that it would be a good idea to have a signed agreement between each municipality to provide emergency evacuation facilities. Our Clerk and I have been conversing via phone calls and emails with the CEMC for Papineau-Cameron working on the set up of a draft agreement.

A draft agreement has been completed and ready for Council to review, make changes or add comments. If Council reviews the documents and agrees on the By-law it will be brought forward at the next Council meeting for approval.

The Township of Papineau-Cameron will be bringing forward this draft by-law and agreement to their Council at the next meeting they will be holding for approval to move forward as well.

- THAT the Mayor and CAO/Treasurer are hereby designated as signing officers and authorized to execute the Mutual Agreement with the Corporation of the Township of Papineau-Cameron to Provide Emergency Evacuation Facilities.
- 2. **THAT** the Mutual Agreement with the Corporation of the Township of Papineau-Cameron to Provide Emergency Evacuation Facilities shall be attached hereto as "Schedule A" (together with it's schedules).
- 3. **THAT** this agreement shall be effective from the date of signing, and shall remain in effect in accordance with the terms of the Mutual Agreement with the Corporation of the Township of Papineau-Cameron to Provide Emergency Evacuation Facilities subject to any amendments thereto or the termination of said Agreement.
- 4. **THAT** all previous By-laws with respect to the Mutual Agreement with the Corporation of the Township of Papineau-Cameron to Provide Emergency Evacuation Facilities be and are hereby rescinded.

"SCHEDULE A" TO BY-LAW 2025-XX

MUTUAL AGREEMENT WITH THE CORPORATION OF THE TOWN OF MATTAWA TO PROVIDE EMERGENCY EVACUATION FACILITIES BETWEEN

THE CORPORATION OF THE TOWNSHIP OF PAPINEAU-CAMERON

(HEREIN AFTER CALLED "TOWNSHIP")

AND

THE CORPORATION OF THE TOWN OF MATTAWA

(HEREIN AFTER CALLED "TOWN")

WHEREAS the Corporation of The Township of Papineau-Cameron may, during emergency situations, require facilities to temporarily accommodate and support its residents;

AND WHEREAS the Corporation of The Town of Mattawa owns and operates the Mike Rodden Arena, which may be suitable for such emergency use;

AND WHEREAS both parties wish to ensure cooperation and preparedness in the event of an emergency evacuation;

NOW THEREFORE the parties agree as follows:

1. <u>DEFINITIONS</u>

For the purpose of this agreement, the term "Arena" shall refer to the Mike Rodden Arena/Community Centre facility located at 450 Hurdman Street, Mattawa ON P0H 1V0.

For the purpose of this agreement, the term "or alternate" shall refer to a property owned by the Town of Mattawa that shall be determined by the Town of Mattawa Community Emergency Management Coordinator (CEMC and Chief Administrative Officer (CAO).

2. PURPOSE

The purpose of this Agreement is to allow the Township to utilize the Arena or alternate as temporary evacuation and emergency shelter facilities, as required, during emergency events affecting the Township.

3. ACTIVATION OF AGREEMENT

This Agreement shall be activated upon written or verbal request by the Township's Chief Administrative Officer (CAO), Emergency Management Coordinator, or designate, and confirmed by the Town's Chief Administrative Officer (CAO) or designate.

4. USE OF FACILITIES

The Town shall make reasonable efforts to make the Arena or alternate available for use during such emergency, subject to the Town's own emergency needs.

5. **DURATION OF USE**

The Arena or alternate facility may be used for the duration of the emergency or as otherwise agreed upon by both parties.

6. COST AND REIMBURSEMENT

Any direct costs incurred by the Town (e.g., staffing, utilities, cleaning, repairs) in supporting the Township's use of the Arena or alternate facility shall be documented and may be subject to reimbursement by the Township or as otherwise eligible for provincial emergency funding.

7. LIABILITY AND INSURANCE

Each party shall maintain appropriate liability insurance. The Township agrees to indemnify and hold harmless the Town for any claims arising from its use of the facilities, except in cases of gross negligence or willful misconduct by the Town.

8. TERMINATION AND AMENDMENTS

- a) This Agreement shall remain in force until either party provides written notice of termination at least 60 days prior to the desired date of termination.
- b) This Agreement may be amended at any time by the mutual consent of the parties, after the party desiring amendment gives the other party a minimum of 30 days' written notice of the proposed amendment.

This agreement shall be binding upon the parties hereto and their successors.

BACKGROUND

The Physician Recruitment Committee consists of appointed Members from Councils of the Town of Mattawa (Raymond Bélanger), Townships of Bonfield (Narry Paquette) and Papineau-Cameron (Mélanie Chenier) and the Municipalities of Calvin (Richard Gould) and Mattawan (Janet McNabb).

Other members of the committee consist of Dr. Bryan Williams (Chief of Staff), Tanya Bélanger (President & CEO), Amy Morrison (VP Corporate Services & CFO/Administrator), Christine Thompson (VP Clinical Services/CNO), Kayla Michaud (Physician Recruiter) and Lyse Coté (Recorder).

ANALYSIS & DISCUSSION

The Physician Recruitment Committee received a report from the President and CEO:

- The Physician Recruiter continues to utilize the Emergency Department Locum Program (EDLP) portal, which is typically utilized when our physicians or locums are unavailable.
- There was a potential ED closure in July, and the situation was being monitored closely.
- Uncertainty remains around the future of the EDLP program. Proposed changes are causing concern among physicians, who may be less inclined to pick up shifts under the new structure.
- An arbitration award was announced in early May, but we are still waiting on a formal funding letter. There is hope for an increase, but nothing has been confirmed.
- We are working on three service agreements in preparation for upcoming transitions:
- Taylor Wilkins began working in the ER in July 2025 and plans to start in the family practice in January 2026.
- DJ Houle is expected to join in July 2026.
- Adam Ritchie is scheduled to join in July 2027 or 2028.
- It remains to be seen what direction the Ministry will take regarding future models of care.
- There may be value in revisiting interest among first-year medical students, particularly in Sudbury, given the recent changes.
- Currently, EDLP shifts are posted 21 days in advance, a change from the previous 45-day window. If a potential closure is anticipated within the next month, the process to address it must begin.

NEW MEMBERSHIP REQUEST

It was noted that the Physician Recruiter received an email from a local community member who expressed interest in joining the Physician Recruitment Committee.

Those present discussed membership and agree that it should be limited to those that are representing a municipality or organization that are financially invested in this initiative. It was acknowledged that any interested individuals could attend Council meetings and, through that process, bring matters forward to this table.

The committee's Terms of Reference will be reviewed at the next meeting. The President & CEO will review and bring a draft forward for discussion.

DATE OF NEXT MEETING

Meetings to be held on a quarterly basis. The next meeting will be scheduled for October 27, 2025.

FINANCIAL IMPLICATIONS

The Council of the Corporation of the Town of Mattawa approved a five-year annual financial commitment of \$13,769.54 per year for the Mattawa Physician Recruitment Initiative. This annual contribution began in 2024 with the final payment in 2028 payable in January of each year.

The VP Corporate Services &CFO/Administrator provided an overview of budget planning and recruitment fund.

The year-end report for March 31, 2025, is included with the report. While the overall operating budget remains under budget, the committee is currently over budget due to the timing of retention incentives. Notably, \$25,000 of the overage was attributed to an early incentive pay out.

We also received a cumulative recruitment fund report, which outlines historical data and current standing.

Looking ahead, the question was raised whether sufficient funds are available to support the recruitment of another physician. The draft budget projects though to 2027/28, with a forecasted shortfall of approximately \$60,000 by 2028. This would mark the first year the program runs a deficit, primarily due to incentive commitments.

If a fourth physician were successfully recruited, there may be an opportunity to extend costs – potentially with renewed municipal support.

I informed the committee that the town's financial resources are tight, and Papineau-Cameron echoed this concern, highlighting that municipalities are under strain due to increased downloading from the province and rising costs just to maintain existing services.

There was discussion around the feasibility of a shared incentive and whether Council might consider splitting a \$25,000 incentive. The President & CEO suggested exploring strategic approach moving forward.

BACKGROUND

Participants from Ontario's counties, small cities and towns attended the 2025 Ontario Small Urban Municipalities (OSUM) Conference hosted by the Town of Collingwood from April 30 to May 2, 2025, at the Georgian Bay Hotel, 10 Vacation Inn Drive. Municipal leaders gathered to explore solutions during economic and political uncertainty.

The OSUM Conference brought us together at an important time. Since January 2025, tariff threats have disrupted global and local economies. It has created new municipal challenges and deepened existing ones.

OSUM represents counties, small cities and towns that are vital links between rural and urban Ontario. These hub communities strive to deliver city-style services, preserve small-town appeal, and protect natural heritage.

OSUM supports dozens of vibrant counties, small cities and towns that connect urban and rural Ontario. While no two communities are alike, small urban municipalities face shared challenges and opportunities that can be both urban and rural in nature.

OSUM's work is driven by an Executive Committee with members hailing from small single-tier cities, suburban towns, rural municipalities and counties. The Executive Committee all sit on the AMO Board's small urban caucus. OSUM's advocacy work is supported by staff at AMO.

Held each spring, the annual OSUM Conference is a significant opportunity for municipal leaders to come together, learn from experts, and work together to address the unique challenges facing Ontario's small urban communities.

ANALYSIS & DISCUSSION

Keynote speakers spoke on the impact of tariffs on Ontario's municipal government and how to foster healthy local democracies. Other sessions focused on sharing innovative solutions and insights into key priorities for Ontario's small urban communities. These include AMO's groundbreaking homelessness study, water and wastewater infrastructure, affordable housing, and cyber-risk.

The Plenary Program consisted of many topics:

- New federal leader, economic restructure and building homes

He highlighted the need to invest in made-in-Ontario clean energy, build up sustainable industries, and protect farmland and the nature that shields communities from floods and extreme weather.

He took aim at the Ford government's priorities, criticizing "wasteful projects designed exclusively for the GTA" like a tunnel under the 401 and the \$2.2 billion subsidy for a foreign owned spa at Ontario Place, while rural hospitals close and municipalities struggle to pay for local roads and bridges.

At the heart of his message was a call for a New Deal for Municipalities — one that includes:

- Uploading costs to the province that have been unfairly pushed onto municipalities and local property taxes
- Dedicated funding to address the mental health, addiction, and homelessness crises
- Predictable, sustainable infrastructure funding for municipalities
- A new funding formula to support hospitals and schools in smaller towns and cities

He also emphasized the need to build 2 million homes: "Let's build homes people can afford in the places they want to live; near people they love — without paving over the farmland that feeds us."

The Honourable Rob Flack, Minister of Municipal Affairs and Housing talked about the province commitment to build 1.5 million homes by 2031 with the application of the 3 S's. Strengthen, Speed Up, and Simplify the legislation.

Municipalities provide services that Ontarians rely on every day. The fiscal framework that enables municipalities to do this work is broken. Failing to fix this problem fails residents, small businesses, health and public safety partners, and major industries.

OSUM, through AMO, calls on Premier Ford to do what taxpayers expect – work together with municipal governments to get it done for Ontarians. Strong and sustainable municipalities mean safe, healthy, affordable and prosperous communities through investments in what Ontarians care about most, including:

- **Housing:** Municipalities own and operate half a trillion dollars of public infrastructure. Over the next 10 years, they are planning for more than \$250 billion of capital expenditures with around \$100 billion related to growth.
- **Healthcare:** In 2022, municipalities across Ontario spent \$3.3 billion on health despite only receiving \$1.8 billion in provincial grants. When public health, long-term care, and ambulance funding don't keep pace with need, we see the impacts in hospitals across the province.
- **Cost of Living:** Ontario has the second highest property taxes in Canada, and they continued to rise as municipalities deal with inflation, growth, and issues like homelessness. Property taxpayers including seniors on fixed incomes and struggling small businesses simply cannot afford to pay for more.
- Public Safety: Municipal resources fund police forces. The impacts of inadequate approaches to mental health, addictions, and homelessness challenges put police resources under strain.

OSUM, through AMO, continues to ask the provincial government to sit down with municipalities and work together on a social and economic prosperity review. This should include a joint review of revenues, costs and financial risks, as well as an analysis of Ontario's infrastructure investment and service delivery needs.

The goal is to update the provincial-municipal fiscal relationship to support strong economic foundations, sustainable communities, and quality of life. While these conversations are already happening in the media and at dinner tables, a comprehensive discussion needs to happen between both orders of government.

AMO's Memorandum of Understanding with the provincial government is the ideal framework for a formal collaboration where we can work together to achieve real results for Ontarians. The municipal fiscal sustainability challenge is urgent, province-wide, and central to Ontario's social and economic prosperity.

On behalf of municipalities, AMO is calling on the provincial government to make investments that will improve the quality of life of Ontarians in communities across the province. Municipalities need a provincial partner that will:

- Sustainably invest in public infrastructure to support growth, improve transportation, and prepare for the impacts of climate change.
- Reduce the province's \$4 billion reliance on municipal revenues to fund provincial programs, like health and social services, so municipal tax dollars can go toward supporting thriving communities.

• Take action on the root causes of homelessness through investments in mental health and addictions programming and improved income security that allows people to keep a roof over their heads.

There are no delegation meetings at OSUM, which removes the unique opportunity for our Council to engage with Ministers, Parliamentary Assistants, and senior Ontario Government officials on local matters that impact our municipality.

The OSUM Executive Committee appreciate the recent budget relief that the Ontario government committed to assist municipalities in managing the unanticipated budget pressures related to OPP billing. This financial support for 2025 was very important as small urban municipalities are facing increasing financial and legislative pressures in many areas. We will need to turn our attention to understanding what the OPP billing pressures mean for us beyond 2025. OSUM is eager to understand what the government is planning to manage this and support municipalities beyond the coming budget planning year.

The Executive Committee also discussed ongoing challenges small urban municipalities are facing in working to meet community infrastructure needs against our economies of scale. It is understood that the ability to meet our communities housing needs against legislative requirements, community growth and our resources is a formula that does not work. OSUM on behalf of our municipal members and colleagues, asks for the government to review these challenges and to step in to assist in a meaningful and sustainable way.

BACKGROUND

Council has previously approved the closure and sale of the unopened James Street and Rankin Street road allowances (see Attachment 1- Public Notice for greater detail).

Recently we have also received a request to purchase the unopened Peter Street road allowance (also on the attached).

ANALYSIS AND DISCUSSION

These transactions date back to my predecessor and in the transition, the files have "fallen between the cracks".

The Town has a policy and procedure (P&P) for the closure and sale of unopened road allowances (see Attachment #2). Several of the steps identified in the P&P have been completed.

In the case of the James Street and Rankin Street unopened allowances, all steps have been completed except the public meeting, the execution of the Purchase and Sales Agreement together with final payment and the actual closure (legal process).

With respect to the Peter Street unopened allowance, the file dates back to at least 2020 where the prospective buyer states that abutting neighbours were notified and with there being no objection, the Town would sell the road allowance provided the prospective buyer purchased the property known as 561 Mattawan Street. This was done but the sale of the road itself has not been completed.

The issue for me is that I have no documentation that the previous Council approved the sale, that the abutting neighbour is not interested in their 50% nor there being a public meeting to announce the closure of the road allowance. There is also no evidence of a property valuation.

Therefore, the first step would be for council to approve the closure and sale of the Peter Street unopened road allowance and direct the CAO/Treasurer to notify the abutting neighbour to determine their interest in their 50% of the allowance and to obtain a property valuation to determine the selling price.





POLICY:	CLOSING AND SALE OF MUNICIPAL ROAD ALLOWANCES SCHEDULE "B" TO BY-LAW 16-17
Committee:	Planning Services Department
Effective Date:	September 26, 2016
Most Recent Revision:	September 23, 2016

SCOPE

This policy applies to the closure and sale of road allowances by the Corporation of the Town of Mattawa.

The Municipal Act provides that a Council of a Municipality may pass by-laws for stopping up all or part of a highway and for selling the same. A highway includes any road under the municipality's jurisdiction.

POLICY

The municipality will consider requests to stop-up, close and sell municipally owned road allowances provided:

a) The unopened road allowance is deemed to be not required for current or future municipal use:

b) Council's policy is that where road allowances abut the shores of rivers and are not required for public access to the water, such road allowances may be closed by the municipality;

c) all costs (survey costs, legal fees, etc.) are borne by the applicant and/or to those persons

whom the lands are to be sold. There shall be no expense to the municipality.

d) Section 34(7) of the Municipal Act, 2001 c.25, provides that a By-law which has the effect of permanently closing or altering a highway is not valid if the result is a person having no motor vehicle access to and from the person's land over any highway, unless the person agrees to such by-law.

It is specifically noted unopened road allowances which lead to waterbodies are of significant interest to not only the municipality but also other government and regulatory agencies. Although an application for closure may be submitted, the applicant should be aware, circulation to and approval from other agencies may be required in addition to municipal approval.

Generally, the municipality will only consider applications for road allowance closings from abutting land owners. However, this is not a legislative requirement and in certain cases, an application to close and convey a road allowance may be accepted from a property owner that does not abut the road allowance.

This policy does not apply to the sale of land under Part XI of the Municipal Act – Sale of Land for Tax Arrears.

This policy does not apply to the Sale of Disposition of Surplus Lands (See Policy for the Sale and Disposition of Land – Schedule A to By-law 16-17.

LEGISLATIVE REQUIREMENTS

Section 11 of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that a lower-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public.

Section 391 of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that a municipality may impose fees or charges on persons:

a) for services or activities provided or done by or on behalf of it;

b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and

c) for the use of its property including a property under its control.

PROCEDURE

1. WRITTEN REQUEST - SUBMISSION REQUIREMENTS

In order for Council to review the request, the applicant shall submit the following information:

- a) A letter of Request to stop-up and close a road allowance shall include an accurate description of the portion of the road allowance requesting to be closed, and a legal description of the applicant's lands.
- b) The Letter shall also contain reasons requesting the closure of the road allowance.
- c) A map of the proposed road allowance to be stopped up and closed, including the identification of adjacent lands, including the location of buildings.
- d) The Applicant(s) shall submit with the written request a non-refundable \$300 fee and a \$2,000 deposit to cover administrative, legal and land value costs.

2. COUNCIL ACCEPTANCE OR REJECTION OF APPLICATION

Once all submission requirements are received, the Clerk will circulate to all departments for comments.

The application and Departmental comments will then be referred to Council for acceptance or rejection. If Council wishes to proceed with the closing and sale of the municipal road allowance, a resolution shall be prepared declaring the land surplus and available for sale. If the recommendation is to reject the application, the applicant(s) will be refunded the deposit less any costs to date.

3. CIRCULATION TO ADJACENT LAND OWNERS

The municipality will conduct a detailed search to ascertain the proper names and addresses of all owners of lands abutting the portion of the unopened road allowance proposed to be closed and sold. A sketch will be prepared showing the holdings of any adjacent owners and the portion of the roadway to which they have a right of first refusal. The adjacent landowners will be contacted in writing, to ascertain their interest in the purchase of

abutting lands. Adjacent landowners will be afforded a minimum of three (3) weeks to respond to the letter. The name(s) and address(es) of all such persons will be noted in the file as well as their decision whether or not to participate and acquire a portion of the unopened road allowance.

Should there be no interest shown in the purchase of the portion of the unopened road allowance, the applicant(s) and any other immediately adjacent landowner who has shown interest in acquiring the lands, will be given the opportunity to purchase the unclaimed portions of such land.

4. NOTICE TO PUBLIC

Prior to selling any municipal road allowance the municipality shall give notice to the public of the proposed closing and sale of the municipal road allowance and hold a minimum of one public meeting.

An advertisement shall be placed in at least one newspaper having general circulation within the local area once a week for a minimum period of two consecutive weeks advising the date, time and location of the public meeting.

The Notice shall also be posted on the municipal website and at the municipal office.

Copies will also be posted in the immediate vicinity of the portion of the unopened road allowance proposed to be closed and sold.

The Notice shall include a brief description of the road allowance and a sketch if at all possible as well as the date, time and location of the public meeting.

After public consultation, a report will be submitted to Council at the next regular or special meeting for further consideration with respect to final decision to close road and at this time a Council resolution is required to proceed to next steps, if applicable.

5. ROAD ALLOWANCE APPRAISAL

The municipality will obtain an appraisal of the fair market value of the unopened road allowance from a person/company certified by the Appraisal Institute of Canada. Once appraisal received copies will be provided to applicant(s) and a letter of intent to proceed must be received by the municipality within thirty (30) days along with a further deposit of ten percent (10%) of appraisal value or at least \$500.00 to confirm desire to proceed by the applicant(s).

If the applicant(s) decide to not proceed with the acquisition the applicant(s) will be responsible for costs associated with advertising and appraisal. Remainder of deposit will be refunded.

Should the applicant(s) decide not to proceed with the purchase once the appraisal has been prepared and does not exercise their option to purchase within thirty (30) days, the second party, if applicable, can proceed to purchase both halves of the road allowance for the appraisal value of each part.

Should neither applicant exercise their right to purchase the road allowance, the appraisal shall have a one-year validity and could be recommenced during this time period with a further deposit of \$1,000.00 and the next steps would proceed.

Council reserves the right to adjust any appraisal if extenuating circumstances become apparent.

6. REFERENCE PLAN (SURVEY) OF ROAD ALLOWANCE

The Applicant(s) shall obtain a reference plan (survey), prepared by an Ontario Land Surveyor, of the area proposed for closing and sale and submit such to the municipality prior to the commencing of any legal work concerning the road closing.

7. CLOSING AND SALE OF MUNICPAL ROAD ALLOWANCE BY-LAW

Once a reference plan has been submitted to the municipality, the municipal solicitor shall be authorized to proceed with the preparation of the legal work concerning the road closing.

The Closing and Sale of Municipal Road Allowance By-law will be brought to Council for formal approval.

The transfer of the land will only be completed once the legal work is completed and after receipt of total payment.

ERRORS AND OMISSIONS

It is acknowledged that any error or omission in following the procedures, in which error or omission was not the result of bad faith on behalf of the municipality will not necessarily render such disposal invalid or void.

PRIVACY

The disclosure of information relevant to the sale of Surplus Lands shall be in accordance with the provisions of the Municipal Freedom of Information and Protection of Privacy Act, R. S. O. 1990, c. M.56, as amended.

BACKGROUND

As indicated in report #25-47R at the September 8, 2025, regular Council Meeting, the pump at the 451 Bisset Lift Station failed. This is the follow-up report.

ANALYSIS AND DISCUSSION

The 451 Bissett Lift Station is the most critical lift station as it pumps all the Town's wastewater to the lagoon. As such, the failure of the pump necessitated the rental of a pump to avoid an environmental disaster. The rental cost is \$8,800 per month going back to late August.

The pump was installed 34 years ago. The parts in the pump have a date stamp of 1978 meaning they were made 47 years ago. The pump is obsolete. You can't buy one like it nor can you get parts for it.

A quote to rebuild the pump from scratch came in at \$137,375.

The existing pump, at 88 HP, was evaluated to be oversized. As such, a quote was obtained for a more suitable 60 HP pump complete with impellor which the old pump did not have.

The price of a new pump was quoted at \$99,890 c/w installation. There is a 2-month turnaround time from the point of order.

As a goodwill gesture, Xylem, the seller, have agreed to waive the rental fee for which, if we order the new one now, would be \$35,200. This huge savings is the main reason why we have not sought other pump dealers.

In addition, OCWA, working in association with Hydro One, submitted on our behalf an energy saving incentive application. The estimated incentive for the Town if we install the new pump is \$8,003.

FINANCIAL CONSIDERATION

The net cost of new pump, installed, is \$91,887 as per the table below.
