#### Mayor D. Backer and Members of Council:

District Homes are unique to Ontario's North. They are long-term homes that have been voluntarily established and financially supported by two or more municipalities and operate on a not-for-profit basis. They are separate, legal entities from the municipalities and are run by a Board of Management comprised of the participating municipalities.

A "Town Hall" meeting was hosted on Thursday March 8, 2018 at 6:00 pm at the Cassellholme Auditorium. This meeting with the municipalities was to formalize the next steps related to redevelopment.

After a very long process that involved reaching consensus related to the path for the redevelopment of Cassellholme which included:

- Resolutions from each municipalities
- Resolutions for every District Home in the Province of Ontario
- Unanimous consent from all provincial parties supporting an amendment to the Long Term Care Act through Bill 160
- Successful draft of the Regulation that support Borrowing Authority for District Homes
- The development and acceptance of a financial plan by the Ministry of Health and Long Term Care, Capital Renewal Branch; and
- The potential to receive up-front capital from the Province of Ontario

#### **Recommendation:**

That the Corporation of the Town of Mattawa recognizes the critical need to redevelop and reimagine senior's care in the Nipissing Region;

That resolutions, supporting the redevelopment, were passed by all participating municipalities and forwarded to the Board of Management of Cassellholme;

That the necessary amendments to the Long Term Care Act specifically Bill 160 now provides for Cassellholme's ability to borrow on their own faith and credit;

That a detailed financial model has been developed and approved by BDO Canada (Appendix A), in consultation with the participating municipalities, Board of Management and senior staff of Casselholme;

That it is understood the next steps includes dissolving the current Board and reconstituting a new Board of Management (per legislative direction) once a final development agreement has been executed, the Town of Mattawa, the Township of Mattawan, the Township of Papineau-Cameron and Township of Calvin have provided their contribution to the capital redevelopment up front or secured by agreement and an associated letter of credit;

# That the Board and member municipalities agree to financially support the redevelopment of Cassellholme and 248 beds AND FURTHER;

AND Direct the Board to secure construction financing at the most favourable rates and terms in order to ensure Cassellholme's long term viability and sustainability.

#### Mayor D. Backer and Members of Council:

In August of 2016 the firm of Mark Elliott Associates presented Council with what was considered to be extremely expensive concepts for the Mattawa River Bridge Dedication Project:

•	Bridge Dedication and Beautification Component	\$229,770.00
•	Floating Boardwalk	\$657,000.00
•	Centre Island Concept 1	\$275.062.52
•	Centre Island Concept 2	\$417,562.50
•	Centre Island Concept 3	\$501,622.50

At the July 24<sup>th</sup>, 2017 Regular Meeting of Council a 2/3 motion was adopted in which Council approved for Jp2g Consultants Inc. to proceed with the 3A proposal of the project and to further report to Council for final approval.

And finally, Report #7.2 at the Monday March 12<sup>th</sup>, 2018 Regular Meeting of Council was reviewed and discussed. Pride of place and heritage was clearly at work throughout the discussions. A spruce up of the town's central core that has been long ignored is being coupled with a meaningful expression of thanks to a native son for a job well done. To date, Council had budgeted \$50,000 in 2017, and hopes to add another \$10,000 in 2018 towards the project, as we are finally in a position to establish a final budget. In addition to the Town's contribution, it is expected that private funds and contributions could, should, and will be added.

#### **Recommendation:**

That the Mayor and Council has reviewed and approved the Jp2g Consultant Inc. proposed Mattawa River Bridge Dedication Project. Further, that the Corporation of the Town of Mattawa allocate an additional \$10,000 in the 2018 budget in order to fund the project.
