### Notice of Nominations for Office

*Municipal Elections Act, 1996 (s.32) as amended*

NOTICE is hereby given to the Municipal Electors of the Town of Mattawa. Nominations for the offices of:

**MAYOR (1)  
COUNCILLORS (6)**

Nominations for these offices may be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the prescribed nominations filing fee of \$200.00 for the Head of Council and \$100.00 for Councillor. The filing fee is only payable by cash, certified cheque, money order or electronic payment (debit, Visa or MasterCard).

A nomination form must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1, 2018 and July 26, 2018 and between 9 a.m. and 2 p.m. on Friday July 27, 2018 (Nomination Day).

In the event there are insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday August 1, 2018 between the hours of 9 a.m. and 2 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

A nomination must be certified by the Clerk before such person becomes a certified candidate for the office to which she or he is nominated.

SPEND FUNDS UNTIL THEY ARE REGISTERED WITH THE CLERK.**

### Notice to Third Party Advertisers

*Municipal Elections Act, 1996 (s.88.3-88.7) as amended*

Under the Act, a registered third party advertiser is an individual, corporation or trade union that has registered with the Clerk. Third party advertising is separate from any candidate's campaign, and must be done independently from a candidate. Any advertisements or materials that are made and distributed by a candidate, or under a candidate's direction, are part of the candidate's campaign.

Any advertisements that incur an expense which includes broadcasts, print, electronic or other medium and has a purpose of promoting, supporting or opposing a municipal candidate (Member of Council or School Board Trustee) requires a Third Party Advertiser to be registered.

Third Party Advertiser(s) must be **formally registered** by filing a **Notice of Registration – Third Party – Form 7** with the Clerk between May 1, 2018 and October 19, 2018 and there is no fee.

Registration permits a Third Party Advertiser to promote or oppose any candidate.

**THIRD PARTY ADVERTISERS CANNOT ACCEPT CONTRIBUTIONS AND/OR  
SPEND FUNDS UNTIL THEY ARE REGISTERED WITH THE CLERK.**
