Mayor D. Backer and Members of Council:

Following the "Workplace Harassment and Bullying" seminar, Integrity Management Consulting Group has announced the "Workplace Investigation: Discipline, Harassment and Absenteeism" seminar. This workshop will consist of a case-based and hands-on session, participants will dive into the practical issues surrounding arranging interviews, documenting evidence, following-up on loose ends, and completing any necessary letters and reports. Participants will come away with a solid understanding of management rights surrounding workplace investigations.

This Performance Management in the Workplace program structure will provide seminar participants the ability to have contextual understanding of workplace harassment, an ability to navigate through the Employer's legal obligations, and the confidence to be able to properly complete a workplace investigation on harassment.

This full day seminar for Employers will take place on November 16, 2018 in Sudbury at a cost of \$350 plus HST per participant.

Recommendation:

It is recommended that the Council of the Corporation of the Town of Mattawa authorize the CAO/Treasurer, Public Works Supervisor, and the Recreation and Facilities Services Manager to attend the Integrity Management Consulting Group's "Workplace Investigation: Discipline, Harassment and Absenteeism" seminar being held in Sudbury on November 16, 2018 at a cost of \$350.00 per participants for a total cost of \$1,050.00 plus HST and that normal travel policy will apply.
