WHEREAS during National School Bus Safety Week (Oct 21-25, 2019) 5 stop-arm violations were observed over the span of 4 days in the town of Mattawa;

AND WHEREAS almost twenty years ago, Adam Ranger - a local Mattawa resident tragically lost his life while crossing the street in front of his home after exiting the school bus because a driver ignored the school bus with extended stop arm and flashing lights;

AND WHEREAS the safety of students in the Town of Mattawa is of paramount concern;

AND WHEREAS the province of Ontario will produce regulations allowing for the use of stop-arm camera video evidence to be used as stand alone evidence in court to lay fines on drivers who pass a stopped school bus;

AND WHEREAS the province has indicated through correspondence that it is up to the school boards and municipalities to implement this technology in their jurisdictions and subsequently submit their programs to the province to assist with the development of the regulations;

AND WHEREAS police are not in a position to adequately police all school buses operating in the Town of Mattawa and would be greatly assisted by this technology and its effect of making our roads safer for students;

AND WHEREAS the Town of Mattawa has already passed a resolution in support of implementing and employing this technology on school buses in the town of Mattawa;

AND WHEREAS other jurisdictions, most notably the City of Ottawa have implemented this technology on their school buses;

AND WHEREAS to properly implement this technology requires the coordination and collaboration between the Town of Mattawa, OPP, Nipissing-Perry Sound Student Transportation Services, school bus operators;

AND WHEREAS BusPatrol is a company that provides stop-arm technology solutions for school buses to government jurisdictions throughout North America;

AND WHEREAS BusPatrol has a stop-arm camera program that reduces stop-arm violations but punishing drivers that break the law;

AND WHEREAS the BusPatrol program can be implemented at no cost to the Town of Mattawa.

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the Town of Mattawa enter into an agreement with BusPatrol, to deploy BusPatrol's stop-arm cameras and associated technology on all 19 buses in the Town of Mattawa with a commitment from the Ontario Provincial Police, the municipality and any other stakeholders to develop procedures to support the program.

AND FURTHER THAT Council forward a letter to the Ministry of Transportation advising the Ministry that the Corporation of the Town of Mattawa is implementing the BusPatrol program and accordingly, submits the prescribed devices and ticket processing procedure for inclusion in the regulations as identified in the BusPatrol program.

BORROWING BY-LAW MUNICIPALITIES

BY-LAW NO. 20-02

WHEREAS the Council of the Corporation of the Town of Mattawa, (the Corporation) deems it necessary to borrow the sum of <u>Five Hundred Thousand dollars</u> (\$500,000.00) to meet, until the taxes are collected and other revenues are received, current expenditures of the Corporation for the year.

BE IT THEREFORE ENACTED as a By-Law of the Corporation as follows:

- 1. The <u>Mayor, Finance Chair, General Government Chair, Treasurer or Clerk/ Deputy-Treasurer</u> are hereby authorized to borrow on behalf of the Corporation from THE BANK OF NOVA SCOTIA (the 'Bank') from time to time by way of promissory note or bankers' acceptance a sum or sums not exceeding at any one time <u>Five Hundred Thousand Dollars</u>, (\$500,000.00) to meet, until the taxes are collected and other revenues are received, current expenditures of the Corporation for the year <u>2020</u>.
- 2. The <u>Any two of the persons listed above in #1</u> are hereby authorized to sign, make or draw on behalf of the Corporation and to furnish to the Bank from time to time promissory notes or bankers acceptances for the sum or sums so borrowed with Interest or any other charges at such rate as the Bank may from time to time determine.
- 3. The <u>Treasurer</u> is hereby authorized and directed to furnish to the Bank at the time of each borrowing and at such other times as the Bank may from time to time request, a statement showing the nature and amount of the estimated revenues of the current year not yet collected or where the estimates for the year have not been adopted, a statement showing the nature and amount of the estimated revenues of the Corporation as set forth in the estimates adopted for the next preceding year and also showing the total of any amounts borrowed in the current year and in any preceding year that have not been repaid.
- 4. All sums borrowed from the Bank and any interest thereon and any other charges in connection therewith shall, be a charge upon the whole of the revenues of the Corporation for the current year and for any preceding years as and when such revenues are received and that the **Treasurer** is hereby authorized to sign on behalf of the Corporation and to furnish to the Bank an Agreement or Agreements of the Corporation charging the said revenues of the Corporation with payment of all sums borrowed from the Bank and any interest thereon and any other charges in connection therewith.
- 5. The <u>Treasurer</u> is hereby authorized and directed to apply in payment of all sums borrowed from the Bank, and of any Interest thereon and any other charges in connection therewith, all of the moneys hereafter collected or received on account or realized in respect of the taxes levied for the current year and for any preceding years and all of the monies collected or received from any other source.

S E C U R I T Y A G R E E M E N T MUNICIPALITIES AND SCHOOL BOARDS

To: THE BANK OF NOVA SCOTIA, (the "Bank")

WHEREAS by a 'By-law or Resolution passed by the <u>Council</u> of the <u>Corporation of the Town of Mattawa</u> on the <u>13th</u> day of <u>January, 2020</u> authority was given to the <u>Mayor, Finance Chair, General Government Chair, Treasurer or Clerk/Deputy-Treasurer</u> to borrow from the Bank the sum or sums therein mentioned and this Agreement was authorized.

NOW IT IS HEREBY AGREED by the Corporation that in consideration of the Bank advancing or providing the said sum or sums to the Corporation that all the revenues of the Corporation of whatever nature and kind are hereby charged to and in favour of the Bank, as security for payment of the monies so advanced or provided by the Bank and any interest thereon and any other charges in connection therewith and the Bank shall have **a** lien upon all such revenues until the charge hereby and by the said By-law or Resolution created is satisfied.

The Corporation represents and warrants that the whole or any part or parts of the revenues of the Corporation are not subject to any prior charge, except as disclosed to the Bank in writing.
