At the August 10th regular meeting of Council, Page 147 of Resolution Number 20-46 declared the property located at 333 Main Street surplus and authorized staff to obtain an appraisal to establish the sale price.

Because the property is classified as Commercial, the appraiser must conduct a full narrative appraisal report in order to be fully compliant with the Canadian Uniform Standards of Professional Appraisal practice at a cost of \$2,500 plus HST. Residential property appraisals generally cost \$400.00 plus HST.

Because the property is in poor condition it is recommended to forego some of the procedures in the Sale and Disposition of Land Policy which in section 3 states that:

- "3.1 Council shall before selling any land obtain at least one appraisal from someone/company certified by the Appraisal Institute of Canada of the fair market value of the land by a person or body qualified to do so.
- 3.2 The list price of surplus land for sale shall be the appraised value determined by a qualified appraiser unless a majority of Council sets a different price by way of motion of Council."

In normal circumstances once the property is declared surplus by Council, an appraisal is conducted and the property is advertised for sale for the appraised price and if it doesn't sell by way of appraised value Council may pass a resolution to re-advertise for 'best offer'.

In order to not incur additional costs a Council resolution is required to declare the sale of the land by Best Offer with an "As is/Where is" clause therefore the following is recommended:

BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa, in consideration of the condition of the property, agrees by majority, to forego Step three (3) of the Sale and Disposition of Land Policy and authorizes staff to advertise the property legally described as PIN 49102-0037 Part of Lot 13 N/S Valois Drive, Plan 1, Village of Mattawan, Part 8, 10, 11 and known as 333 Main Street for 'Best Offer' including an "As Is Where Is" clause.

Mayor D. Backer and Members of Council:

As part of this year's road resurfacing Budget asphalt suppliers and paving companies were asked to provide the municipality with estimates for the required work. There will be two locations on the Main Street/Highway 533 Corridor that require the paving company to complete while our Public Works Department will take care of all other locations around town. There is 53.71 cubic metres of asphalt required for all the projects.

We received two (2) quotes to have the asphalt supplied, which are attached to this resolution. Our Public Works crew will be responsible for retrieving it from their asphalt plant:

- a) Miller Paving at \$147.00 per metric tonne plus HST
- b) Pioneer Construction at \$130.00 per metric tonne plus HST

We received two (2) quotes to supply and place superpave asphalt on two locations on the Main Street/Highway 533 Corridor:

- a) Miller Paving at \$24,500.00 plus HST
- b) Pioneer Construction at \$40,647.00 plus HST

We feel the Pioneer Construction "Supply Asphalt" quote of \$ 130.00 per metric tonne for a total of \$17,106.64 plus HST is the logical choice for this category, and the Miller Paving "Supply & Place Asphalt" quote of \$24,500.00 plus HST is the logical choice for this category.

We were unable to secure a third quote due MTO Paving Specifications.

Recommendation:

BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa authorize the purchase of asphalt from Pioneer construction at a total cost of \$130.00 per metric tonne plus HST which is a total cost of \$17,106.64 and to Miller Paving for the supply and placement of superpave asphalt at a total cost of \$24,500.00 plus HST.

Mayor D. Backer and Members of Council:

The Municipality was successful in receiving funding for the Rehabilitation of the Pont Mauril Belanger Bridge Project through the Ministry of Transportation Connecting Links Program. This funding will enable the municipality to complete the emergency repairs to the West abutment caused by the May 2019 Flood Event.

All bridge related expenses as of April 1, 2020 will be eligible for reimbursement under this funding program. Total eligible expenditures for this project are \$1,423,622.40 and the municipal share representing ten percent of the funding is \$142,362.24. The repairs have commenced and are expected to be completed by mid-November of this year.

Mayor D. Backer and Members of Council:

A regional Mayor's and CAO's meeting was held September 10th via Zoom video platform. Ms. Susan Church of Blue Sky Net chaired the meeting as the purpose was to discuss broadband connectivity within our region.

The ICON and Universal Broadband Funds are severely over-subscribed and it was discussed and decided that the municipality of East Ferris would prepare a resolution of Support to lobby government officials to support Nipissing district municipalities and its First Nations communities by way of reinstating regional funding programs.

Recommendation:

WHEREAS, we the Nipissing communities of the Nipissing-Temiskaming riding, Antoine First Nation, Mattawa/North Bay Algonquin First Nation, Bonfield (Bonfield, Rutherglen), Callander, Calvin, East Ferris (Astorville, Corbeil), Mattawa, Mattawan, Nipissing, North Bay, Papineau-Cameron, Chisholm, Powassan (Powassan, South River, Trout Creek) and Redbridge, seek fast, reliable and affordable internet and e-connectivity for our citizens, our businesses, our non-profit organizations and our visitors;

AND WHEREAS, we form part of Blue Sky Net where internet speed in our communities has been confirmed as substantially lacking as reported in the recently published report entitled "The Speed of Northern Ontario Broadband";

AND WHEREAS, our companies find it difficult to operate in a business environment that is becoming increasingly digitalized;

AND WHEREAS, our citizens are frustrated as the school season resumes and their children require internet for their education programs;

AND WHEREAS, we are concerned that applications for the Improving Connectivity for Ontario (ICON) was severely over-subscribed;

AND WHEREAS, we are equally concerned there has yet to be Federal Government funding announced in support of the ICON fund;

AND WHEREAS, we are more so concerned that our voice will be lost in the sea of funding demands for improved internet and e-connectivity currently being made by communities across our region, our province and our country;

THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa encourages the citizens of our area to raise their voice in support of their municipalities and Blue Sky Economic Growth Corporation (Blue Sky Net) as they look to secure funding for internet for our Nipissing communities; and

THEREFORE BE IT RESOLVED THAT we encourage our MP Anthony Rota and our MPP Victor Fedeli to examine the opportunity to re-instate the role played by our northern economic development agencies (FedNor and NOHFC) in the delivery of internet funding in Northern Ontario as they are best positioned to understand the needs of our region; and

Reg. 316/03, Operation of Off-Road Vehicles on Highways, definitions to include Off-Road Motorcycle and Extreme Terrain Vehicles (Argo, ATV with 6 + Wheels) within the off-road vehicle act, which allows the municipality to permit these vehicles just like ATV's and SXS's on municipal roadways.

NOW THEREFORE the Council of the Corporation of the Town of Mattawa enacts as follows:

That By-Law No. 15-26 be amended as follows:

3. That Section 1. Definitions be amended by adding the following definitions attached hereto:

"extreme terrain vehicle" means an off-road vehicle that:

- (a) has six or eight wheels, the tires of which are all in contact with the ground,
- (b) has no tracks that are in contact with the ground,
- (c) has seats that are designed to be straddled, and
- (d) has a minimum cargo capacity of 159 kilograms;

"off-road motorcycle" means an off-road vehicle, designed primarily for recreational use, that:

- (a) has steering handlebars,
- (b) has two wheels, the tires of which are all in contact with the ground,
- (c) has a minimum wheel rim diameter of 250 millimetres.
- (d) has a minimum wheel base of 1,016 millimetres,
- (e) has a seat that is designed to be straddled by the driver,
- (f) is designed to carry a driver only and no passengers, and
- (g) does not have a sidecar;
- 4. This By-Law shall come into force and effect upon being passed.

The Ministry of Environment, Conservation and Parks (MECP) conducted a Best Management Practice (BMP) inspection last year with Ontario Clean Water Agency (OCWA).

As a result of the inspection, OCWA recommended, as a best practices management policy, that the Town of Mattawa establish a By-law limiting the use and access to our hydrants and water distribution system. Under this By-law the Mattawa Volunteer Fire Department will be permitted access to hydrants for firefighting and/or training purposes as well as licensed operators with a Class 11 Water Distribution and Supply Subsystem license.

This will ensure that only trained personnel will be allowed to operate hydrants and keep our water distribution system safe for the residents of Mattawa.

Recommendation:

BE IT RESOLVED THAT Mayor and Council of the Corporation of the Town of Mattawa adopt By-Law No. 20-25 which is a By-law to Regulate the Use of Hydrants and Water Distribution System within the Town of Mattawa.

BY-LAW NUMBER 20-25

BEING a by-law to regulate the use of fire hydrants and water distribution system within the Town of Mattawa.

WHEREAS subsection 10(2) of the *Municipal Act*, 2001, *S.O.* 2001, *c* 25, as amended provides, that a municipality may pass by-laws respecting the environmental well-being of the municipality, the health, safety and well being of persons and the protection of persons and property;

AND WHEREAS Subsection 429(1) of the Municipal Act, 2001, S.O. 2001, c 25 as amended, provides that municipalities may establish a system of set fines for offences under a by-law passed under the Municipal Act, 2001;

AND WHEREAS Part XIV of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended provides for the enforcement of municipality by-laws;

NOW THEREFORE the Council of the Corporation of the Town Of Mattawa enacts as follows:

1. **DEFINITIONS**

- **1.1** "Fire Chief" means the Fire Chief appointed by the Town of Mattawa.
- **1.2 "Fire Department"** means the Town of Mattawa Volunteer Fire Department.
- **1.3** "Hydrant" means the fire hydrant.
- **1.4** "Operator" means a member of the Town of Mattawa Volunteer Fire Department and/or Public Works person licensed in Class II Water Distribution subject to Section II a).
- **1.5 "Public Works Supervisor"** means the Public Works Supervisor appointed by the Council of the Town of Mattawa.
- **1.6** "Water Works Distribution System" is a part of a water works system with components that carry potable water from a centralized treatment plant or wells to water consumers in order to adequately deliver water to satisfy residential, commercial, industrial and Firefighting requirements.
- **1.7** "Water Works System" is a system of engineered hydrologic and hydraulic components which provide water supply.

2. GENERAL PROVISIONS

2.1 No person shall open, interfere with, operate, or take water from any hydrant without authorization from the Public Works Supervisor and/or the Fire Chief.

- **2.2** No person shall use the hydrants for water supply unless authorized by the Public Works Supervisor and/or the Fire Chief.
- 2.3 No person shall open or close a valve in the water works system or remove, tamper with or in any way interfere with any valve, water meter, structure, water main or water service in the water works distribution system.

3. EXEMPTIONS

- **3.1** Section 2 of this by-law shall not apply to the Mattawa Volunteer Fire Department in the event of fire fighting and/or training.
- **3.2** Section 2 of this by-law does not apply to a licensed operator who is licensed in Class II Water Distribution and Supply Subsystem.

4. OFFENCES AND PENALTIES

4.1 Every person who contravenes any provisions of this by-law is guilty of an offence and upon conviction is liable to a fine as provided for by the *Provincial Offences Act, R.S.O.* 1990, c. P. 33, as amended, as per Schedule "A" attached hereto and forming part of this by-law.

5. FORCE AND EFFECT

5.1 This by-law shall come into force and take effect on the date of passing.

Mayor D. Backer and Members of Council:

At the July 27th regular meeting, Council approved Page 127 of Resolution Number 20-42 for the flood restoration of the marina docks anchorage system by Galcon Marine Ltd at an estimated cost of \$28,000.00.

Additional discussions since has changed the scope of work requested by Galcon Marine Ltd. The extra work will involve the removal and relocation of approximately thirty-two feet of the main dock. This work will reduce the length of the main dock projection into the Ottawa River and realign the skewing that occurred during the flood event.

There will also be electrical costs incurred in order to disconnect the electrical power and reconnect after the re-alignment work is completed. These costs have not yet been determined.

Galcon Marine Ltd. has scheduled the work to be completed the week of September 21st. Council approval for the additional work is required.

Recommendation:

BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa approve the additional estimate provided by Galcon Marine Ltd. to remove and relocate thirty-two feet of the main dock at a cost of \$5,500.00.

AND FURTHER THAT this work will involve a contingency allowance for additional materials of approximately \$1,200.00 in case the existing deep water anchors cannot be readily salvaged.
