THE CORPORATION OF THE TOWN OF MATTAWA BY-LAW NUMBER 21-28

BEING a by-law to amend the schedule of fees and charges for the Town of Mattawa.

WHEREAS the *Municipal Act*, 2001, S.O. 2001, c.25, Section 391, authorizes a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of any other municipality; for the use of its property, including property under its control; and for capital costs payable by it for sewage and water services or activities which will be provided or done by or on behalf of it after the fees or charges are imposed; and

WHEREAS all fees or charges imposed pursuant to the By-law are due and payable by the person invoiced therefore, immediately upon receipt of the invoice; and

WHEREAS unpaid fees or charges imposed pursuant to the By-law are subject to an interest rate of one and one quarter per cent per month; and

WHEREAS the fees or charges imposed pursuant to this By-law constitute a debt owing to the Corporation of the Town of Mattawa, and without limiting any collection remedy otherwise available to the municipality, the Corporation of the Town of Mattawa may add outstanding fees and charges, including interest on the unpaid balance pursuant to the preceding paragraph of this By-law, to the tax roll for any real property within the municipality owned by the person responsible for paying the fees and charges, and the amount may be collected in a like manner as municipal taxes; and

WHEREAS Council adopted a consolidated fees and charges By-law in 2017 (By-law 17-06) for fees and charges for a variety of services the municipality provides; and

WHEREAS it now deemed necessary to amend the consolidated fees and charges by-law for the Corporation of the Town of Mattawa.

NOW THEREFORE, the Council of the Corporation of the Town of Mattawa does hereby enact as follows:

- 1. **THAT** the Landfill Services Schedule "J" attached hereto are hereby deleted in its entirety and replaced with a new Schedule "J" and forming part of this By-law.
- 2. **THAT** the fees as listed in amended Schedule "J" will be subject to Harmonized Sales Tax (HST) where applicable.
- 3. **THIS** By-law amendment shall come into force and effect on the date of its passing.

One Tender was received in the amount of \$90,000 with the required deposit of tewnty percent in which Council was advised at the Special meeting of November 30th, 2021.

The successful tenderer shall be responsible for all costs incurred or required to dispose of the property with the exception of advertising and appraisal costs. These include, but are not limited to encumbrances and legal fees. The municipality makes no representation regarding title or any other matters relating to the land to be sold. Surplus land is sold 'as is'.

Mayor D. Backer and Members of Council:

During the course of the year the Accounts Receivable Department has been busy issuing invoices and collecting receivables for all services within the Town of Mattawa.

Beginning in May of this year the Municipal Office underwent changes to the department and one change was the creation of the Revenue Services Clerk.

Invoices dated as far back as 2015 were reviewed and statements of account were mailed out to all companies that had an outstanding billing with hopes of recovering the revenue. After speaking with several companies and some with no response the Revenue Services Clerk worked with the Treasurer on how to manage the uncollectable revenue.

Currently, there is no policy in place for the collection of receivables which amount to \$2,718.77.

For these reasons it is recommended:

BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa authorize the Treasurer to write-off uncollectable receivables in the amount of \$2,718.77.

The newly hired CEO for the John Dixon Public Library made a presentation to Council at the regular meeting of November 22, 2021. Ms. Lahaie updated Council on the re-opening of the facility and its plans going forward. Council was very pleased with the presentation which included plans for purchasing much needed equipment, new books, software and gaming system.

Ms. Lahaie also provided a report showing what transpired with the insurance claim proceeds with respect to the fire that occurred in summer of 2018.

In 2020, \$52,000 was budgeted for the Library subsidy; \$24,000 was disbursed and the remaining allocation was set aside which amounted to \$28,000.00.

For this year \$36,000 was budgeted rendering the outstanding subsidy amount to be \$64,000.00. The Library is in need of these funds to continue their operations as they are currently using their insurance proceeds to offset their operating costs. Council was pleased with the re-opening of the Library and it is therefore recommended that the outstanding subsidy be disbursed therefore the following is recommended:
