## 3. Construction Update

Mr. Demeis provided the Committee with updated photos and reviewed the progress with the construction up to date. Construction has been completed with the exception of a minimal amount of last-minute finishes. Delivery of mailboxes are backordered until June. Picnic tables for Pavilion will arrive the week of May 16<sup>th</sup>.

The interior of the units along with the furnishings and decoration for the community room has been completed. The washers and dryers in the laundry room has been installed and are available for tenant use. All roofing repairs have been completed. The Affordable Senior Housing Project construction portion has now been completed. The Descon Construction Team have demobilized, utilities have been transferred and final warranty paperwork will be issued.

As of May 4, 2022, a total of 52 applications have been received and the Descon Management Group continue to receive applications.

The status of the received applications to date is as follows:

- 50 applications have been fully processed.
- 5 people have backed out of applying
- 2 applications need to be provided more information
- 8 applications are rejected
- 7 are waitlisted for 2 bedrooms or 1 bedroom plus den
- 1 application have recently been received and not yet processed
