22-04 Draft By-Law X Item Policy Recommendation

Mayor D. Backer and Members of Council:

The Mattawa Fitness Centre has been leasing the lower level in the Voyageur Curling Club facility for one year now which was under a one-year lease agreement. The lease is up for renewal and the Curling Club is raising the monthly rent by \$50.00 due to increased operating costs with respect to utilities, i.e. heating costs.

With the increase, the monthly rent will be \$800.00 per month plus HST. There is a clause in the lease agreement which addresses mandatory provincial pandemic closures which reduces the monthly rental costs by 50% if and when we are mandated to be closed.

For these reasons the following is recommended:

BE IT RESOLVED THAT Council of the Corporation of the Town of Mattawa adopt By-law 22-04 to renew the Mattawa Fitness Centre lease agreement with the Voyageur Curling Club for the year 2022 in the amount of \$800.00 plus HST per month.

BY-LAW NUMBER 22-04

BEING a by-law to authorize the execution of a lease agreement between the Corporation of the Town of Mattawa and the Voyageur Curling Club.

WHEREAS Subsection 8 of the Ontario Municipal Act 2001, S. O. 2001, c. 25 empowers and authorizes a municipality to enter into agreements to enable them to govern their affairs as they consider appropriate;

- 3. **THAT** this agreement shall be effective and shall remain in effect and force in accordance with the terms of the agreement subject to any amendments thereto or the termination of the said agreement.
