# Mayor D. Backer and Members of Council:

Caisse Populaire Alliance Ltée is providing temporary borrowing arrangements for the 333 Main Street Development Project which will convert the existing building into shell condition ready for future sale of the property.

Council approved By-law 22-16 at the May 2<sup>nd</sup>, 2022 Special Meeting of Council which authorized the signing of the Design Build Contract with Descon Construction Ltd in the amount of \$653,100.00 plus HST.

Caisse Alliance is providing bridge financing at prime plus 1% with no interest payments payable until December 31, 2022 at which time the full amount will come due. The financing offer is attached which is set-up to only disburse funds required as needed to the approved amount of \$738,003.00.

A resolution authorizing the financing is required therefore the following is recommended:

### Recommendation:

**BE IT RESOLVED THAT** Council of the Corporation of the Town of Mattawa approve Bylaw No. 22-27 which will approve the short-term borrowing financing agreement for the 333 Main Street Development Project with Caisse Alliance Ltée in the amount of \$738,003.00 and authorizes the Mayor and CAO to execute the agreement on behalf of the municipality.

### **BY-LAW NUMBER 22-27**

**BEING** a by-law authorizing the signing of a financing loan agreement with Caisse Alliance Ltée to provide for short-term loan financing for the 333 Main Street Development Project.
