# CORPORATION OF THE TOWN OF MATTAWA

## BY-LAW NUMBER 22-30

**BEING** a by-law to authorize the execution of an amendment to the Design Build Contract with Descon Construction Ltd.

**WHEREAS** the Council of the Corporation of the Town of Mattawa did enter into a design build contract with Descon Construction Ltd. on the 2<sup>nd</sup> day of May, 2022 to render the municipal building known as 333 Main Street to a shell condition;

**AND WHEREAS** both Parties have agreed to amend the contract to incorporate Change Order #001;

**AND WHEREAS** it is deemed necessary to authorize the execution of a design build contract amendment.

**NOW THEREFORE** the Council of the Corporation of the Town of Mattawa hereby enacts as follows:

1. **THAT** the Existing Contract hereby be attached to this By-law as Appendix "A" to this Amending Contract.
2. **THAT** the Corporation of the Town of Mattawa authorizes Change Order #001 with Descon Construction Ltd. as outlined in Appendix "B" attached to and forming part of this By-law.
3. **THAT** the Mayor and CAO/Treasurer are hereby authorized to execute on behalf of the municipality, the Change Order #001 with Descon Construction Ltd..
4. **THAT** the By-law shall come into force and take effect on the date of its passing.
