THE CORPORATION OF THE TOWN OF MATTAWA BY-LAW NUMBER 22-32

BEING a by-law to authorize the purchase and transfer of land.

WHEREAS it is deemed expedient and in the interest of the Town of Mattawa to purchase the land being 1216 John Street legally described as PT. LOT 15 CONCESSION 14 PAPINEAU AS IN NB60458 EXCEPT PT 1 NRD1679; S/T NB122270; PAPINEAU CAMERON; DISTRICT OF NIPSSING.

AND WHEREAS Subsection 8 of the Ontario Municipal Act 2001, S. O. 2001, c. 25 empowers and authorizes a municipality to enter into agreements to enable them to govern their affairs as they consider appropriate;

AND WHEREAS Council for the Corporation of the Town of Mattawa authorizes the purchase of the said land to for the sum of two dollars (\$2.00);

AND WHEREAS Council of the Corporation of the Town of Mattawa will continue to utilize this property for recreational services as long as it is deemed feasible to do so.

NOW THEREFORE, the Council for the Corporation of the Town of Mattawa hereby enacts as follows:

- 1. THAT 1216 John Street, designated as PT. LOT 15 CONCESSION 14 PAPINEAU AS IN NB60458 EXCEPT PT 1 NRD1679; S/T NB122270; PAPINEAU CAMERON; DISTRICT OF NIPSSING be transferred to the Corporation of the Town of Mattawa for the sum of two dollars (\$2.00).
- 2. THAT Schedule "A", being the Purchase and Sale agreement is attached and forms part of this By-law.
- 3. THAT Schedule "A" includes a five-year lease to the Voyageur Curling Club with an option to renew as per the details in the attached lease which forms part of this By-law.
- 4. THAT the Mayor and CAO/Treasurer for the Corporation of the Town of Mattawa are hereby authorized to execute such documents as may be necessary and to attach the corporate seal thereto.
- 5. THIS By-law shall come into force and take effect upon the date it is passed and when a certified copy is registered in the Land Registry Office, at North Bay, Ontario.
