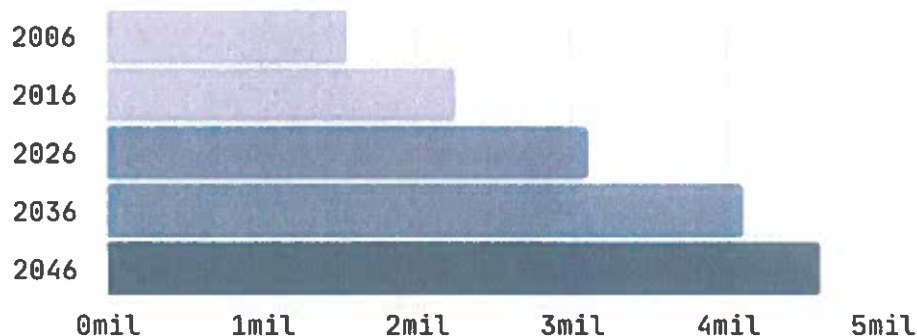

How many beds for how many baby boomers?

- There are going to be **9.6 million** Baby boomers who die in Canada by 2050. For reference, **160,596** military and civilian Canadians died due to WWI, Spanish flu and WWII, combined.
- Of these 9.6 million baby boomers, 2.4 million live in Ontario as of 2017 and this will increase to **4.6 million Baby Boomers by 2046.**
- 34.4% of baby boomers will need palliative care in Ontario, that's 1,582,430 baby boomers in Ontario.
- Ontario has a reported number of 4,000 hospital palliative beds and 491 residential hospice palliative beds. **4,491 beds for nearly 1.6 million baby boomers.**
- **Estimated Cost of Hospital Palliative Care bed: \$15,000/day.**
- **Estimated Cost of Hospice Palliative Care bed: \$5,000 a day.**

What about NNPCN?

- NNPCN served 1477 clients in 2021-2022.
- Each client cost **\$135.41 per year to serve.**
- **\$0.37 per client per day**, while other palliative care beds cost up to \$15,000 to maintain a day.
- Compare this to the average cost of other visiting hospices at \$80/day.
- **Cost of NNPCN services per client per 3 services: \$0.02/hour.**
- **NNPCN operates at 0.0025% of a residential hospice / hospital's annual budget per client.**

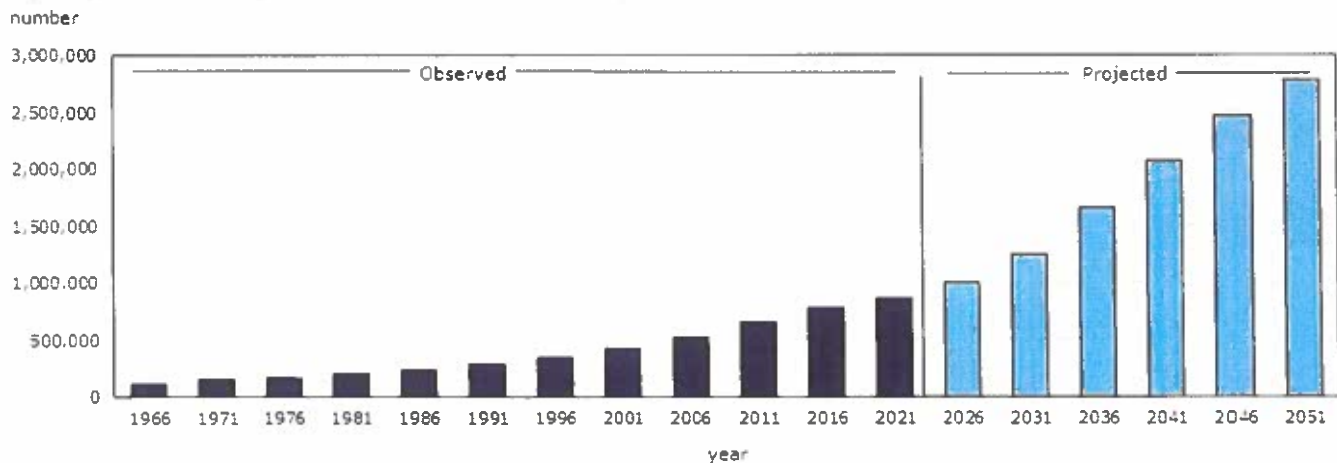

Dear Council,

This note is a request for a dog park for the City of Mattawa for the following reasons:

1. There is a consistent number of dogs in the City the owners seem unwilling or unable to confine, leash, walk or control;
2. Dog walkers should have the right to walk around with freedom and free of significant stress or fear related to their dog's safety;
3. Given the employment challenges in the region, it is presumable that when (*not if*) a dog attacks another dog, the owner responsible will not be able to pay the significant vet bill that will accompany such an event.

Therefore, the problem in front of us is economic, social and moral. I understand that a by-law officer can be called in these situations, but I would estimate that 50% of the time I walk my dog, I encounter a loose dog or one that the owner does not have control over. I cannot be expected to be carrying my phone on every walk and phoning the City 3-5 times a week. Walking one's dog should not become some kind of combat exercise or detective game. It is a healthy way for people to exercise throughout the year and key part of physically caring for the dog one owns.

As as no one has the right to prohibit any else from buying a dog, a dog park would deal with many of these issues to at least *some degree*.

If someone is mentally, physically, or logistically incapable of walking their dog or fencing their dog in, they could drive up to the park and let their dog go for a run and defecate. This would also 1) socialize the dog ultimately reducing aggression, 2) reduce stress on the dog owner by helping reduce the dog's energy levels and stress, 3) and reduce stress on dog walkers who do not want to be charged by loose dogs or dogs who have broken their chains in order to bolt at a passerby.

I also think the fact that the arena parking lot in the winter (which is often empty) magically transforms into an informal place to let your dogs run loose is an indication from the real need for

such a park. Unlike the arena parking lot, however, the park would not have to be plowed and upkeep for such a park is minimal notwithstanding the upfront fencing costs. Despite those, I think the advantages of such parks far outweigh any disadvantages.

Can the council pass a resolution to begin to site locations for a potential dog park?

AMO Policy Update – New Affordable Child Care Spaces, Information from Province on More Homes Built Faster Plan, Energy Reports Released, Annual Emergency Exercise Requirement, Golf Car Consultations Underway

Increase In Affordable Child Care Spaces Across the Province

The Ontario government is creating an additional 53,000 new, affordable licensed child care spaces by December 2026. This announcement is part of the six-year, \$13.2 billion agreement with the federal government to lower fees for families and deliver an average of \$10 per day child care by September 2025. The focus of this new targeted plan is to increase access for families across Ontario. The new spaces will be allocated to communities using a model that incorporates demographics, socioeconomic indicators and existing licensed child care capacity. The spaces will be part of the Canada-wide Early Learning and Child Care system and includes a mix of not-for-profit and for-profit centres. The province will also enhance the availability of flexible models of care for a changing economy and labour market including spaces available on weekends and overnight.

Ontario is also launching a \$213 million grant program for new and existing operators. These one-time grants, prioritizing regions with low rates of space availability, will help child care operators offset the initial costs of expanding or creating spaces such as purchasing equipment or renovating facilities.

New Information from Province Regarding the More Homes Built Faster Plan

The Minister of Municipal Affairs and Housing provided an update to Heads of Council on December 22, 2022 regarding recent legislative and regulatory changes. It provides important information about the implementation of Bill 109, Bill 23, Bill 3 and 39.

On December 28, 2022, the Minister of Natural Resources and Forestry provided direction for conservation authorities (CAs) regarding fee changes associated with planning, development and permitting fees. On the same day, the Ministry also provided additional information to conservation authorities (CAs) and participating municipalities on legislative and regulatory changes affecting CAs.

New Reports Released by the Independent Electricity System Operator (IESO) and Ontario Energy Board (OEB)

In December 2022, the Independent Electricity System Operator (IESO) released a series of reports recently that pertain to the transformation of Ontario's electricity system. The IESO's Pathways to Decarbonization Report was released in response to the Ministry of Energy's request that IESO evaluate a moratorium on procurements of new natural gas generating stations in Ontario and develop a pathway to zero emissions in the electricity sector.

The report provides a summary of the dependencies, risks and opportunities involved in the potential 2027 moratorium on natural gas generation in Ontario's electricity system, and the transition to decarbonization. It also lists actions to help ensure Ontario can both manage uncertainty and seize new opportunities as they emerge. The report was informed by IESO's 2022 Annual Planning Outlook and 2021-2024 Conservation and Demand Management Framework Mid-Term Review.

Also in December 2022, the Ontario Energy Board (OEB) released a new document: Improving the Electricity Planning Process in Ontario: Enhanced Coordination between Municipalities and Entities in the Electricity Sector. It intends to build municipal awareness about the regional electricity planning process and identify information that Local Distribution Companies need from municipalities to improve the accuracy of electricity load forecasts. It is one of many initiatives being actioned in the Regional Planning Process Advisory Group's report, Recommendations to Improve Ontario's Regional Planning Process which was delivered to the OEB on December 20, 2021.

Annual Emergency Exercise Requirement

Effective December 22, 2022, municipalities are no longer required to conduct the annual practice exercise in a year where:

- The Municipal Emergency Control Group (MECG) directed the municipality's response in an emergency during that year, and the emergency lasted for at least 48 hours;
- The MECG implemented the municipality's emergency plan and the MECG's procedures to respond to an emergency during that year; and
- The MECG complies with any other requirements that may be specified.

This update intends to provide municipalities flexibility in the allocation of emergency management resources while ensuring emergency management plans are tested annually through the annual practice exercise or responding to an emergency.

Invitation to Golf Car Consultations

The Ontario Ministry of Transportation has been piloting golf cars in two municipalities (Huron-Kinloss and Pelee Island) since June 2021. The pilot allows golf cars to be operated on-road, subject to any regulatory restrictions.

Given the success of the pilot to date, the ministry is exploring a prospective expansion. Please sign up and attend ministry-led consultations on February 1 to provide any feedback related to this potential expansion.

Dear Heads of Council,

I'm pleased to share an update on key initiatives underway at my ministry to help meet our government's goal of building 1.5 million new homes over the next 10 years.

The legislature recently passed our government's *More Homes Built Faster Act, 2022* which takes bold action to ensure that all communities can grow with a mix of ownership and rental housing types to meet the needs of all Ontarians.

Our government knows that building inspectors play a critical role in ensuring that new homes meet the public safety requirements set out in Ontario's Building Code. However, the capacity of municipal building departments has been impacted by recruitment challenges and the increasing number of building inspectors retiring from the profession. That's why, earlier this year, we took action to help municipalities address labour supply shortages in the building sector by amending the Building Code to provide a new model for municipal building departments to design and administer internship programs for building inspectors.

Effective July 1, 2022, municipal building departments can establish program entry criteria for interns that meet their own local recruitment and enforcement needs. This new internship model supports public safety by continuing to require that a qualified building inspector or Chief Building Official supervises the work of interns. The interns must also pass ministry technical and legal exams before being able to practice independently as building inspectors.

In the coming months, the ministry will develop guidance materials to support municipalities that are interesting in launching local programs to recruit new intern building inspectors. We look forward to working with municipalities to implement local internships.

Additionally, the ministry has engaged a consultant to identify opportunities for enhancements to the qualification program for building practitioners. We are seeking input from the public, including municipalities, building inspectors, designers, septic installers and building professionals not regulated by the ministry. This feedback will help guide future decisions on new approaches to qualification.

In addition to this ongoing work, the ministry is modernizing the provincial Qualification and Registration Tracking System (QuARTS). QuARTS is used by over 7,000 building practitioners to update their qualification and registration information online and to help the government regulate safety and compliance in the Ontario building industry.

Modernizing QuARTS will create a more efficient and user-friendly system, allowing building officials to spend more time on the important task of reviewing and issuing building permits to support the government's key priority of increasing housing stock.

Finally, the ministry made the 2012 Building Code Compendium freely available in Adobe PDF format through the website (<https://www.ontario.ca/page/request-digital-copy-2012-building-code-compendium>). Since its launch in March 2022, the ministry has provided free copies to over 5,000 building professionals to reduce barriers and help accelerate the construction of new homes across the province. This initiative has enabled inspectors to access Building Code requirements while performing their work onsite in a more convenient format. Additionally, candidates studying for the ministry's exams are able to access and learn Building Code content in an easy to navigate, user-friendly manner.

As part of the plan to build 1.5 million homes over the next 10 years, the government looks forward to continuing consultations with municipalities, the building industry and the public to investigate further changes to Ontario's Building Code in order to create more housing and support public safety.

- Must get approval of your temporary patio from your local [municipality](#)
- Must [notify](#) the AGCO of your approval, the duration of your approval and any conditions on the approval (see [Notifying the AGCO of an Approved Temporary Patio](#))
- **Please note: The AGCO no longer accepts applications or otherwise approves temporary patios for licensees in municipalities.**

Licensees on First Nations Reserves:

- Must get approval from the AGCO, unless the Band Council has chosen to manage temporary patio approvals (see [Temporary Patios on First Nation Reserves](#))
- Must [notify](#) the AGCO of any temporary patios approved by a Band Council, the duration of your approval and any conditions on the approval
