### THE CORPORATION OF THE TOWN OF MATTAWA BY-LAW 23-16

**BEING** a By-law to appoint Paul Laperriere as Interim Chief Administrative Officer for the Corporation of the Town of Mattawa.

**WHEREAS** subsection 229 of the Municipal Act, 2001 provides that a Council of the Town of Mattawa may pass a by-law to appoint a Chief Administrative Officer who shall be responsible for:

- a) Exercising general control and management of the affairs of the municipality for the purpose of ensuring the efficient operation of the municipality; and
- b) Performing such other duties as are assigned by the municipality.

**AND WHEREAS** Council deems it essential to appoint a Chief Administrative Officer for the municipality;

**NOW THEREFORE** the Council of the Corporation of the Town of Mattawa enacts as follows:

- THAT in the absence of CAO/Treasurer Francine Desormeau the municipality hereby appoints Paul Laperriere as Interim Chief Administrative Officer on a 6 month contract.
- 2. **THAT** Paul Laperriere shall exercise all the authority, powers and rights and shall perform all the duties and obligations as the Chief Administrative Officer which by statute or by by-law are or may be conferred or imposed upon and any other duties that may be imposed by Council.
- 3. **THAT** this By-law shall be effective for a 6 month period commencing on the 23<sup>rd</sup> day of May and terminating on the 24<sup>th</sup> day of November, 2023.

- a) Collecting money payable to the municipality and issuing receipts for those payments;
- b) Depositing all money received on behalf of the municipality in a financial institution designated by the municipality;
- c) Paying all debts of the municipality and other expenditures authorized by the municipality;
- d) Maintaining accurate records and accounts of the financial affairs of the municipality;
- e) Providing the council with such information with respect to the financial affairs of the municipality as it requires or requests;
- f) Ensuring investments of the municipality are made in compliance with the regulations made under section 418.

#### **BY-LAW 23-18**

**BEING** a By-law to appoint Paul Laperriere as Interim Deputy-Treasurer for the Corporation of the Town of Mattawa.

**WHEREAS** subsection 286(1) of the Municipal Act, 2001 requires that Council of the Town of Mattawa shall appoint a Deputy-Treasurer who is responsible for handling all of the financial affairs of the municipality on behalf of and in the manner directed by the council of the municipality, including:

- a) Collecting money payable to the municipality and issuing receipts for those payments;
- b) Depositing all money received on behalf of the municipality in a financial institution designated by the municipality;
- c) Paying all debts of the municipality and other expenditures authorized by the municipality;
- d) Maintaining accurate records and accounts of the financial affairs of the municipality;
- e) Providing the council with such information with respect to the financial affairs of the municipality as it requires or requests;
- f) Ensuring investments of the municipality are made in compliance with the regulations made under section 418.

**AND WHEREAS**, The Municipal Act, Section 286(2) provides that a municipality may appoint Deputy-Treasurers who shall have all the powers and duties of the Treasurer under this and any other act;

**NOW THEREFORE** the Council of the Corporation of the Town of Mattawa enacts as follows:

- THAT in the absence of Deputy-Treasurer/Payroll Coordinator Scott Lacelle the municipality hereby appoints Paul Laperriere as Interim Deputy-Treasurer on a 6 month contract.
- THAT Paul Laperriere shall exercise all the authority, powers and rights and shall perform all the duties and obligations as the Treasurer which by statute or by by-law are or may be conferred or imposed upon and any other duties that may be imposed by Council.
- 3. **THAT** this By-law shall be effective for a 6 month period commencing on the 23<sup>rd</sup> day of May and terminating on the 24<sup>th</sup> day of November, 2023.
