for the reconstruction of Mattawan Street from Pine Street intersection to Park Street intersection (a distance of 560 m) including

Part A Pine Street to Hurdman Street: 340 meters asphalt removal including 150 mm of Granular A' removal, catchbasin removal and replacement, outlet culvert removal and replacement, grading, granular base, hot mix paving, asphalt gutter, storm and sanitary structure frame adjustments and landscaping

Part B Hurdman Street to Park Street: 220 meters tack coat and asphalt overlay from Hurdman Street to Park Street.
