for the reconstruction of Dorion Road Hill from Highway 17 southerly a distance of 430 meters including a new curve as well as preparation of adjacent rock storage area and contractor lay-down area. The work also includes but is not limited to paving, Granular 'A' base, Granular 'B' subbase, earth excavation, grading, rock excavation grading, grubbing, culvert replacement, pavement marking, signage, landscaping, on-site stockpile of surplus excavated earth and on-site stockpiling of surplus excavated rock.

Construction will take place over 2 construction seasons with substantial completion scheduled for October 15, 2025.

The successful Bidder will be required to file with the Owner the specified bonds and insurance within ten (10) days of being awarded the Contract.
